Gentlemen:—An examination of the transcripts for the above bond issue discloses that the transcript for the issue of \$18,300.00 contains the information that the engineer's estimate for the improvement to be paid by this issue amounts to \$16,042.04. To this amount there was added interest at 6% for ten years amounting to \$5,313.00, making a total of \$21,355.04. Upon the estimate submitted in this form, the council of the village has proceeded to issue bonds in a total amount of \$18,300.00. Section 2295-11 G. C. provides as follows:

"The cost of construction of any building, utility or improvement may be construed to include interest payable during construction on bonds issued for such construction. A sum not to exceed one year's interest on any bond issue may be included in the amount of the issue to the extent necessary to care for interest maturing previous to the receipt of the taxes or assessments from which such interest is to be ultimately paid."

As this issue contained an amount for interest in excess of the provisions of the foregoing section, the officials of the village were advised that the issue of bonds could not be met for more than \$17,000.00. This department was then advised that the bonds have been issued and are now held by different purchasers so that it is impossible to comply with the request and reduce the amount of this issue.

In view of this situation the issue of \$18,300.00, Hower Street paving bonds, cannot be approved, and you are advised not to accept this part of the issue of said bonds.
