Narrative:

On October 15, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) completed a review of the video captured from the body-worn camera (BWC) of Officer Abrianna Franklin (Officer Franklin) during this incident. Officer Franklin created two separate BWC videos relevant to this investigation and both videos were reviewed as noted below.

Amped Replay was used to review the videos.

SA Valente made working copies of the two BWC videos and placed the copied videos in a folder on his BCI issued laptop. The working copies of the videos were used for the review.

The Amped Replay software noted the following:



The BWC video began as Officer Franklin stood at the rear of 1309 Yellowstone Road at the northeast corner of the home's garage. As the video began, Officer Erica Perez (Officer Perez) was also present standing near Officer Franklin. Approximately 51 seconds into the recording, Officer Perez left this position and began walking towards the front of the home along the home's north side.

Officer Franklin then assisted other officers in the subject's front yard in dealing with the subject's father, Ferrel Thomas (Ferrel). Ferrel was upset and was requesting to see his son and enter his home. Ferrel paced around his front yard in the following

minutes requesting to know if his son was alive or dead, if he had been placed in an ambulance and who told him to come outside.

Beginning around 26 minutes into the recording, Ferrel asked, "Who the fuck told me to come outside. Officer Perez responded, "I think we all did. We wanted to get you outside to question you to see what was..." Ferrel interrupted before Officer Perez couldn't finish speaking. Ferel responded, "So you could fucking kill him? I know you all didn't want to; I know." The officers then attempted to get Ferrel to sit with his daughters who were also in the front yard.

Beginning around the 35:30 mark of the video recording, Officer Franklin joined other officers in verifying that the house was clear of any other people. After clearing the house, Officer Franklin took a position near the rear of the home to secure the scene. Officer Franklin stood at or near the rear of the home for the remainder of the video.

All frames referenced above, except for the start time and end time frames, were bookmarked as images in Amped Replay. The images were exported to the folder "Ofc. Franklin BWC 1 Derivatives and Reports."

An Amped Replay report was generated for Officer Franklin's first BWC video review and bookmarked images. The report was exported to the same folder noted above. Please refer to the report for further details. The Amped Replay reports for the BWC videos were attached to this report. Refer to this report for further details.

The video file working copies, the Amped Replay bookmarked images, and the Amped Replay reports were copied to a USB thumb drive and were placed into the BCI physical case file as Reference Item N.


