**Narrative:**

On Tuesday, August 27, 2024, at approximately 1430 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) returned ten (10) items of evidence to the Akron Police Department (APD), which is located at 217 South High Street, Akron, Ohio, 44308. The items, which had been photographed on the date of the incident by SA Bynum while both APD Officers were still wearing the uniforms and equipment, were returned due to having no evidentiary value.

The items of evidence were collected as part of the investigation regarding BCI case #2024-2465. SA Tingley contacted APD Sergeant Steve Null, who signed for and took custody of the ten (10) items of evidence.
