Details:

On December 12, 2021, at approximately 1700 hrs., S/A Justin Soroka received a call from S/A/S Josh Durst in reference to an agent request. The Cuyahoga County Sheriff's Office was investigating an Officer Involved Critical Incident involving Police Officers with the City of Cleveland. The Sherriff's Office was requesting assistance processing the scene.

On December 12, 2021, at approximately 1815 hrs., S/A Justin Soroka arrived at the intersection of Superior Ave. and E. 12<sup>th</sup> St. and met with Detective Tom Roberts. S/A Soroka learned that a handgun taken off of the subject was secured in a Cleveland Police Department Vehicle. S/A Soroka met with Captain James Dziuba, who had custody of that handgun. Capt. Dziuba stated that he had received the gun from Sergeant Mike Urbania, and it was placed in Cleveland Police Vehicle #3552. S/A Soroka retrieved the handgun, magazine, and a jacketed bullet, which was reportedly recovered from the subject's clothing, from the trunk of Vehicle #3552. S/A Soroka created a chain of custody on the firearm box the handgun was placed in, and had Capt. Dziuba sign the box. S/A Soroka photographed the handgun, which was a Taurus G2c 9mm, bearing serial number ACE957899. The magazine was a 12 capacity, 9mm magazine, which contained 7 cartridges marked with the headstamp "RP 9mm Luger". The magazine was packaged with the handgun and identified as item #95. The jacketed bullet was photographed, packaged, and identified as item #96. The items were turned over to S/A Ashley Ornelas.

It was reported that the subject was walking on the north sidewalk of Superior Ave. between E. 12<sup>th</sup> St. and E. 13<sup>th</sup> St. S/A Soroka and Cleveland Police Crime Scene Detective Daryl Johnson searched the north sidewalk and the street/curb area of Superior Ave. from E. 12 St. to E. 13 St. and did not locate any cartridge cases. S/A Soroka and Detective Johnson also searched the sidewalk, planters, bus stop enclosure, building façade, etc. on the south side of Superior Ave. between E. 12<sup>th</sup> St. and E. 13<sup>th</sup> for bullet impacts and did not locate any.
