**Narrative:**

On February 9, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Armstrong (Armstrong) received the Strongsville Fire Department run report from Southwest General Medical Center Police Chief Tristan Harker. The report was associated with the October 18, 2022, emergency run which resulted in patient Bryan Bailey being transported to the Southwest General Medical Center. A copy of the run report has been attached to this report.

The narrative below was taken from page 3 of the EMS Run Report:

**Narrative History Text:**

M3 dispatched to residence for a male attempting to cut himself with scissors. PD also responding. On arrival crew was led inside by family member. She reports pt showed up at home today and began throwing items and was attempting to harm himself with a pair scissors. Family was able to deescalate pt. Family reports pt has history of psychiatric issues and has been off of his medications for a month.

Upon pt contact, pt sitting upright in chair. ABCs intact, appears distraught. Pt is A+Ox4 but uncooperative with interview. Pt reports he just wants to go to sleep, not answering any other questions. Pt has a few superficial cuts on chest. Family, crew and PD were able to convince pt to allow transport. Pt walked to cot, secured and moved into squad.

Verbal report called to SWGH ED. No changes to pt condition en route. Care transferred with ED SBAR to RN Christine in exam 3.
