On May 6, 2025, Special Agent Doug Eveslage reviewed the Paulding County Sheriff's Office, 180 Constitution Boulevard, Dallas, Georgia 30132 report documenting a lost/missing firearm from victim, Peyton Chase Pruitt, which occurred on June 9, 2021. The CZ 9mm firearm with serial number B702918 was entered into GCIC as lost.

On April 18, 2025, the Norwood Police Department recovered the lost firearm while executing a search warrant on Akeem Holtz's 2012 red Dodge Caravan.

Supplemental Report

On 06/09/2021, while on duty and assigned to the front lobby! 501 at the Paulding County Sheriff's Office, I spoke with the Complainant! Victim, Mr. Peyton Pruitt by telephone. Mr. Pruitt reported a lost weapon to me. Below is a summation of the incident reported to this Deputy.

Mr. Pruitt stated between the hours of 1530-1545 on this date (6/9/2021) his dog got loose and ran off. He took his hand gun, a CZ 75B Omega, Serial Number B702918, 9MM, Black in color off and set it on his vehicle then chased after his dog. When he returned to his vehicle he drove off and forgot about his gun. When he remembered the gun he got out and it was now gone. A search of the area met with negative results. The gun is now missing. It has been entered into the GCIC on this date as lost. The gun was valued at \$450.00.
