Narrative:

On Tuesday, April 05, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Butterworth (SA Butterworth) received requested records and recordings from Franklin County Sheriff's Office (FCSO) Sgt. Billy Duffer. SA Butterworth had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications-related information for the following date and time period: March 7, 2022 at 0930 hours, until March 7, 2022, at 1700 hours. As a result of that request, the following items were received and reviewed:

Computer Aided Dispatch (CAD) Records:

SA Butterworth received from the Franklin County Sheriff's Office the FCSO Detail Call Sheet. Contained within the record is information relating to the date, time, and log information for the incident.

Radio Traffic Recordings:

SA Butterworth received from the Franklin County Sheriff's Office (FCSO), a recording of radio traffic and phone calls from this incident. The recordings are combined into one single file, a control room phone call file, and a radio traffic file. For the purposes of this report, SA Butterworth utilized the combined recording and reviewed the individual recordings.

During the recording, at 00:12, a radio transmission is recorded from someone requesting a supervisor to the parking garage and advises of the incident and requests patrol assistance. At 00:33, Chief 2 radios in the garage looking for the 7th floor. At 02:10 a radio transmission is recorded from 163 D (Deputy Feery) requesting the garage to be shut down.

911 Calls:

There were no 911 calls regarding this incident recorded and provided to SA Butterworth.

Other Phone Calls (other than 911):

SA Butterworth received from the Franklin County Sheriff's Office (FCSO) a recording of phone calls that were recorded during the incident. The recording was combined with FCSO radio traffic. At 00:50, the control room from facility services contacts dispatch to advise of the incident- and requests detectives. At 01:17, Major Oyer calls dispatch to advise of a "52" and requests detectives. At 01:50, dispatch advises Columbus Fire to enter the scene and requests a second medic.

Mobile Data Terminal (MDT) Communications:

SA Butterworth received from the Franklin County Sheriff's Office (FCSO) an Excel spreadsheet that contains MDT communications from the date of the incident. This information is difficult to decipher and a copy of it will be attached to this report for the reader's viewing.
