#### Narrative:

On Sunday, March 16, 2025, at approximately 0430 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) arrived at the Ravenna Police Department (RPD), located at 220 South Park Way, Ravenna, Portage County, Ohio, to meet with the involved RPD Officers and collect evidence relevant to the March 16, 2025, officer-involved critical incident.

At the RPD, SA Tingley met with SPD Captain Smallfield, who stated that both of the involved officers, Sergeant Cristopher Coy (Coy) and Officer Brock Wise (Wise), were present at the RPD. SA Tingley asked Captain Smallfield where the officers' weapons used during the incident were located. Captain Smallfield stated that both Sergeant Coy and Officer Wise had retained their respective weapons and that both had their weapons in their holsters on their duty belt.

SA Tingley then met with Sergeant Coy and Officer Wise. SA Tingley asked each officer if they wished to make a statement, and both responded that they wished to speak with counsel before making any statements. SA Tingley also explained the BCI investigation process to the officers and Captain Smallfield.


SA Tingley then had each officer move to an unobstructed area where SA Tingley took four (4) photographs of each officer (one photograph from the front, one photograph from the rear, and one photograph from both the left and right sides). These photographs were taken on SA Tingley's cellphone while both Sergeant Coy and Officer Wise had their duty weapons in their holsters on their duty belt, which each officer was still wearing.





SA Tingley then collected Sergeant Coy's firearm which had been used during the incident. Sergeant Coy's firearm was a department-owned Shadow Systems Model XR920 9mm handgun with a Streamlight TLR 1 HL light and a Holosun green dot sight attached. The serial number of Sergeant Coy's firearm is \_\_\_\_\_\_\_. The weapon had one round in the chamber and fourteen rounds in the magazine which was in the weapon. Each of the two spare magazines which were on Sergeant Coy's duty belt were loaded with seventeen rounds. SA Tingley photographed the handgun from both sides and each magazine was unloaded and the cartridges from the magazine placed beside

it with the round removed from the chamber placed near the magazine removed from the handgun. SA Tingley then photographed all three magazines and the cartridges.

#### Sergeant Coy's Handgun and Magazine Count



SA Tingley then collected Officer Wise's firearm which had been used during the incident. Officer Wise's firearm was a department-owned Shadow Systems Model XR920 9mm handgun with a Streamlight TLR 1 HL light and a Holosun green dot sight attached. The serial number of Officer Wise's firearm is the weapon had one round in the chamber and fourteen rounds in the extended magazine (which held nineteen rounds) which was in the weapon. Each of the two spare extended magazines (which was capable of holding nineteen rounds) was checked. One of the spare

magazines was loaded with nineteen rounds and the other spare magazine was loaded with eighteen rounds. When asked, Officer Wise stated that the one spare magazine was only loaded with eighteen rounds but did not remember why it was not fully loaded. SA Tingley photographed the handgun from both sides and each magazine was unloaded and the cartridges from the magazine placed beside it with the round removed from the chamber placed near the magazine removed from the handgun. SA Tingley then photographed all three magazines and the cartridges.
