Narrative:

On April 1, 2022, at approximately 20:54 hours, Ohio BCI Special Agent (SA) Jack Shea (Shea) attempted to identify the deceased driver of a tan 2000 Chevrolet Malibu 4S, VIN 1G1NE52J7Y46174532 and bearing Ohio registration HHQ-1258. The deceased driver was involved in an officer-involved shooting with the Struthers Police Department in Youngstown, Ohio. SA Shea determined through OHLEG, that the vehicle registration came back to Lloyd Greenwalt (Greenwalt), who resides at 4213 Burkey Road, Apt. 2, Austintown, Ohio. The OHLEG picture of Greenwalt did not match the deceased driver of the Malibu. At this time, SA Shea requested the Austintown Police Department interview Greenwalt, in an attempt to identify the deceased driver.

On April 1, 2022, at approximately 21:47 hours, in an effort to identify the deceased driver, Patrolman Ryan Mong (Mong) of the Austintown Police Department went to 4213 Burkey Road, Apt. 2, in Austintown and spoke to Greenwalt. This interview was recorded with a body camera and has been attached to this report. Greenwalt stated that he had problems with his driver's license (suspended license) and wanted to get rid of the Malibu, so he wouldn't be tempted to drive the vehicle. Greenwalt went on to tell Mong that he agreed to sell the Malibu to his nephew, Dustin Greenwalt (Dustin), for \$100.00.

When Dustin picked up the Malibu, Greenwalt asked Dustin to remove the rear license plate and return it to Greenwalt when Dustin had a chance. Greenwalt stated that Dustin never returned with the license plate. Greenwalt went on to say that he hasn't seen Dustin in four days and that he is not answering his [Greenwalt's] telephone calls. When asked by Mong, Greenwalt gave Dustin's phone number as 234-248-3269.

When Greenwalt was asked about his nephew Dustin, Greenwalt told Mong that Dustin had come to Greenwalt's apartment with a black male approximately four days ago to get the Malibu. Greenwalt stated he did not know the black male and described Dustin's friend as a male black, approximately 50 years old, with black hair, black beard and wore glasses. Greenwalt believed the black male worked as a roofer with Dustin. Greenwalt did not know the name of the roofing company, and thought the two picked up roofing jobs as independent contractors.

Greenwalt advised Mong that he didn't want to file a report but wanted the incident documented. At this time, Mong showed Greenwalt a picture of James Sheets (Sheets) as a possible driver of the Malibu. Greenwalt advised Mong that he has never seen Sheets and did not know who he was.

Mong left Greenwalt's apartment at approximately 22:01 hours.
