On Monday, November 24, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Dan Boerner examined / photographed seven (7) items of clothing collected during the autopsy of John P. Adams (Adams).

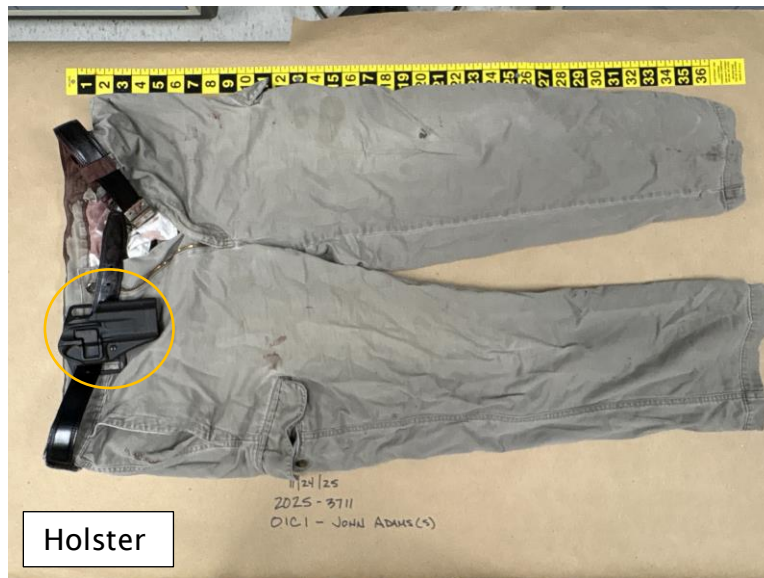

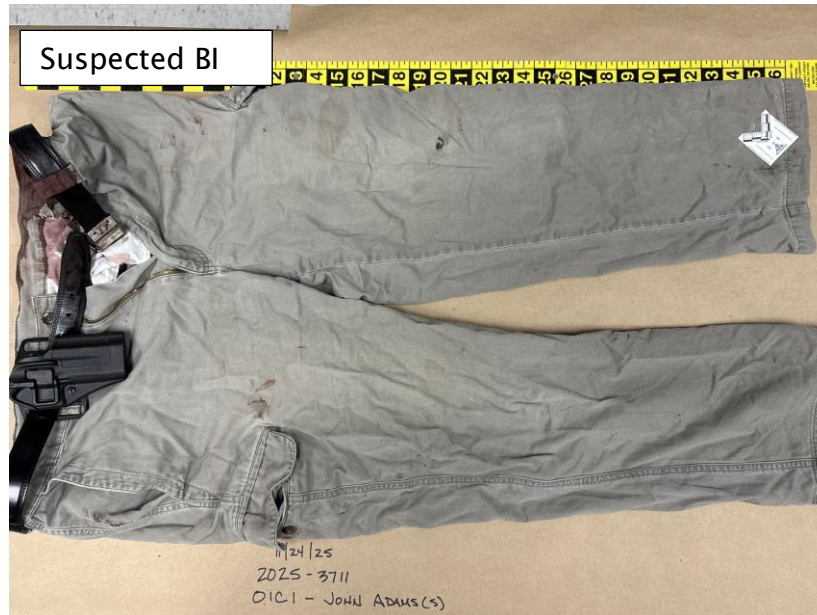


Figure 9, Matrix Item 033

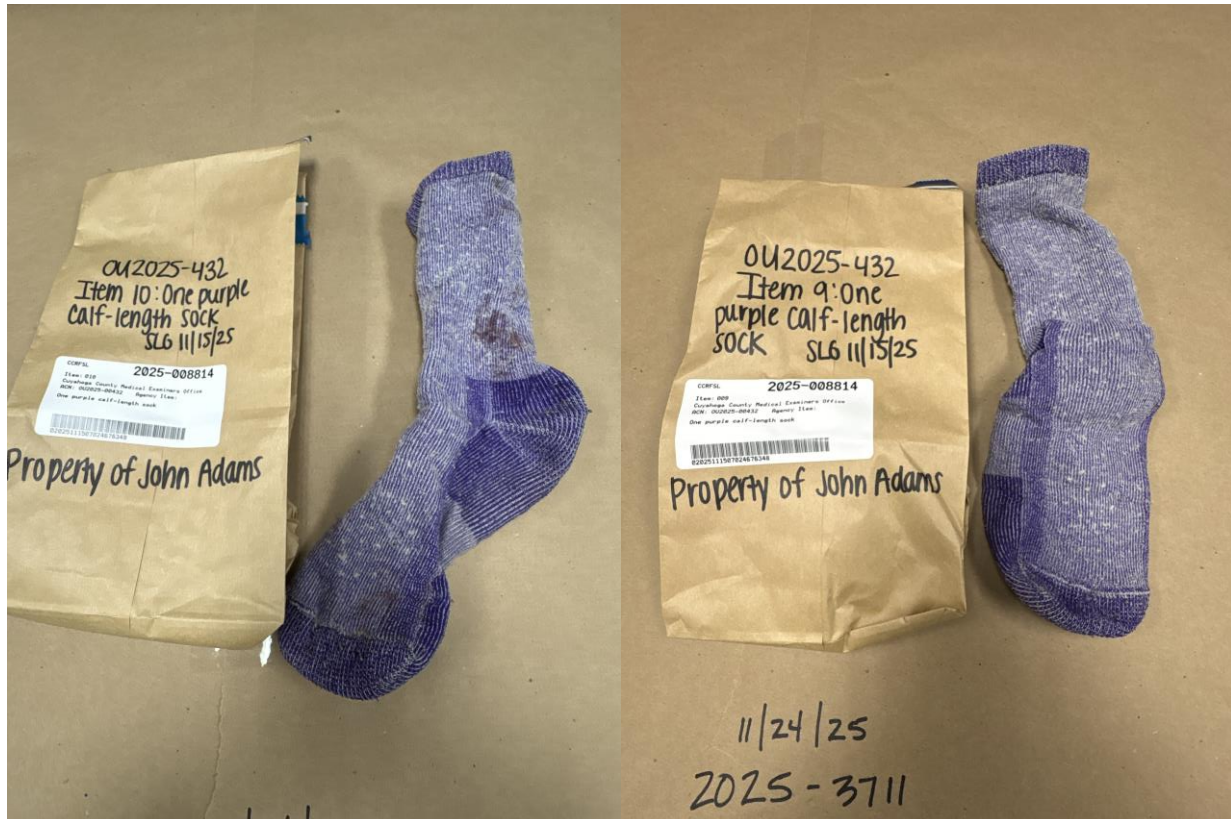

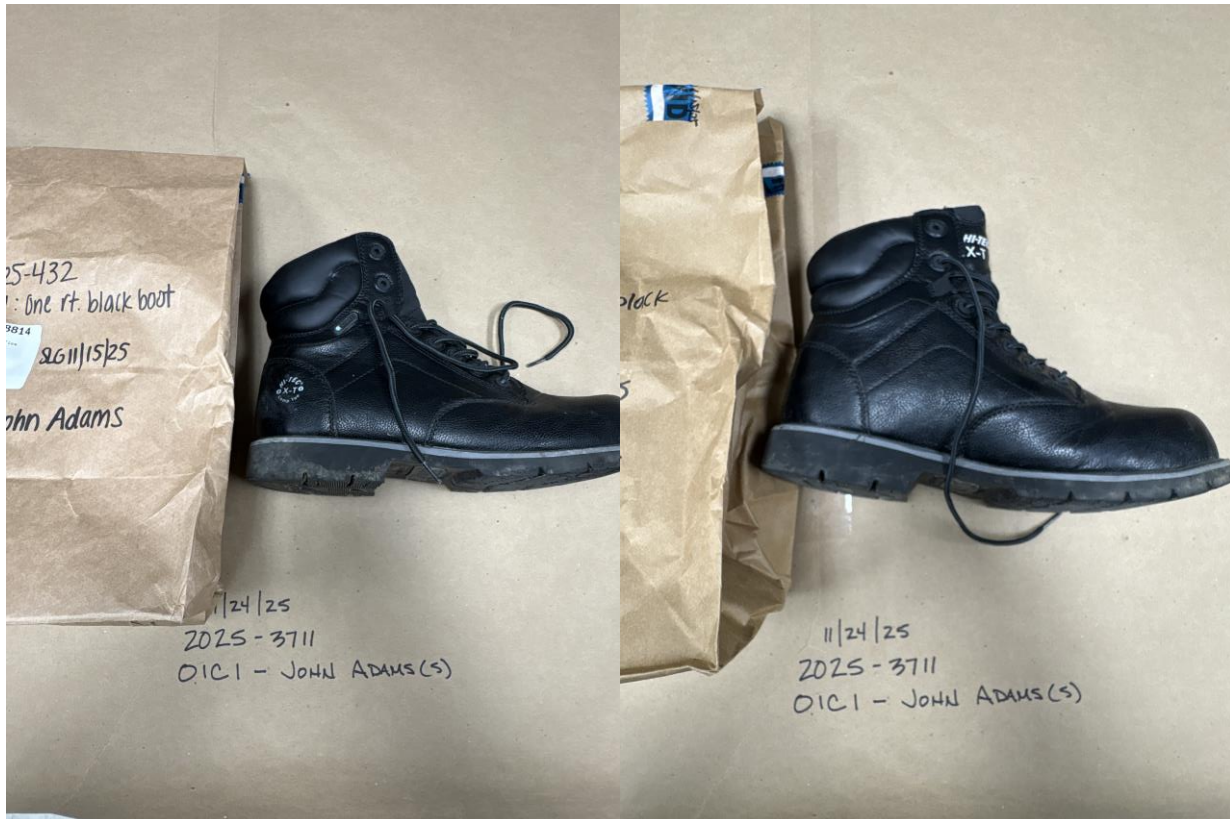
