On July 8, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matthew Armstrong (Armstrong) executed a search warrant to T-Mobile for Jayland Walker's (Walker) cellular phone records, including location date.

Also on July 8, 2022, SA Armstrong executed a search warrant to Google for account and location detail records related to Jayland Walker's Google account.

On July 14, 2022, SA Armstrong received the requested results from T-Mobile.

On July 26, 2022, SA Armstrong requested that the Ohio BCI Criminal Intelligence Unit (CIU) map out Walker's location using the T-Mobile records throughout the day of June 26, 2022, and leading up to the shooting incident. On July 26, 2022, CIU was provided a copy of the T-Mobile records.

On January 13, 2023, SA Momchilov was advised that the Geolocation Records Analysis report was completed and uploaded into Matrix.

The Geolocation Records Analysis were from June 25, 2022-12:02:05 AM, through June 27, 2022-12:59:57 AM.

SA Momchilov reviewed the Geolocation Records Analysis.

The reader of this Investigative Report is encouraged to review the "Geolocation Records Analysis-J. WALKER" before reading this report further. The Geolocation Records Analysis Report is attached to this Investigative Report.

**Conclusion**

**June 26, 2022 10:06:15 PM through June 27, 2022, 12:36:33 AM**

On June 26, 2022, between 10:06:15 PM and 10:08:25 PM, approximately two and a half hours prior to the shooting, Walker's device is observed leaving his residence. For the next approximately two and a half hours, Walker's device appears to travel throughout the area of the Akron-Canton airport, New Franklin and Akron. During this time, Walker does not receive or send any text messages or chats. Walker does not make any phone calls and only receives one phone call. The phone call was from his mother, Pamela Walker, at 10:29:29 PM, and the duration of the call was 2 minutes and 57 seconds.



At this time, Uber Eats and DoorDash records indicated that Walker was not working and that the last deliveries made by Walker were: DoorDash-June 24, 2022, at 5:21 PM, Uber Eats-June 25, 2022, at 5:52 PM.

Investigators examined Walker's phone and could not locate any other applications that would suggest that Walker was conducting any other type of delivery service or employment. Also, during the two and a half hours, Walker's device does not appear to stay in one area for any substantial period of time. On several occasions, Walker's device is observed in the same area at different times.

For example at 11:12:00 PM, Walker's device is located in the area of 3778 Manchester Road. At 11:22:29 PM, approximately 10 minutes and 29 seconds later, Walker's device is once again in the area of 3778 Manchester Road (Figure 1).



Another example, at 10:42:38 PM, Walker's device is located in the area of 14 West Bartges Street. At 11:55:17 PM, Walker's device is once again in the area of 14 West Bartges Street (Figure 2).

In reviewing the Geolocation Analysis Report, it appears that Walker's device is traveling aimlessly with no set destination. There are also two unusual instances that may possibly suggest that Walker was attempting to seek out law enforcement.

### **New Franklin Vehicle Pursuit**

On June 26, 2022, at approximately 2:30 AM, Jayland Walker's vehicle was involved in a pursuit with the New Franklin Police Department. During that time, Walker's device was in the area of his residence. Based upon a statement obtained from New Franklin Officer Robert

Wagner (Wagner), Officer Wagner was sitting stationary at Akron Uniforms, located at 4410 Manchester Road, when he observed Walker's vehicle. Officer Wagner stated that he decided that he was going to conduct a traffic stop on that vehicle for an equipment violation. Officer Wagner pulled out and began traveling southbound on State Route 93; by the time Officer Wagner pulled onto the roadway, another vehicle was traveling between him and the vehicle that he intended to pull over. Officer Wagner continued to follow the vehicles, when he observed the vehicle that he intended to pull over pull into Subway located at 5105 Manchester Road. The vehicle then turned around and re-entered the roadway, now traveling northbound on State Route 93. Officer Wagner stated he turned around in the carwash parking lot and got behind the vehicle. Officer Wagner then turned on his overhead lights. Based upon Officer Wagner's statement, radio traffic and dispatch records, the below map (Figure 3) illustrates Officer Wagner's stationary position at Akron Uniforms, the area where Walker's vehicle turned around and the pursuit route.



Investigators are aware of the possibility that Walker loaned his vehicle to another individual and that Walker may not have been the driver during the June 26, 2022 pursuit with New Franklin Police. Investigators attempted to interview every individual on Walker's phone contacts list. No individual interviewed advised that they borrowed Walker's vehicle. No other individuals came forward and advised that they borrowed Walker's vehicle. Also, in reviewing all the available information and records, such as text messages, chats and phone logs, investigators could not locate any indication that an individual borrowed Walker's vehicle. Furthermore, on June 26, 2022, approximately 1 hour and 15 minutes prior to Walker's incident with the Akron Police Department, Walker's device is located in the area of the New Franklin pursuit that occurred the morning before. The below map (Figure 4) illustrates the time and location of Walker's device in relation to the New Franklin pursuit.


It is bizarre behavior for someone who was involved in a vehicle pursuit to go back to that area in such a short period of time.

**2.**

Officers [REDACTED] ([REDACTED]) and [REDACTED] ([REDACTED]) both advised in their interview that they were in the area of North Howard Avenue and Tallmadge Road when they initially observed Walker's vehicle. Both noted that the vehicle had an equipment violation. When Walker's license plate was ran, the officers noted that the vehicle had been involved in a pursuit on June 26, 2022. Officer [REDACTED] and Officer [REDACTED] decided to follow Walker's vehicle until it entered Route 8 southbound from Tallmadge Road. At this point, officers decided not to conduct a traffic stop on Route 8 due to safety concerns with stopping a vehicle on the highway.

[REDACTED] Walker's device was also observed in the area of North Howard Avenue and Tallmadge Road at 12:22:35 AM (Figure 5).

Officer [REDACTED] and Officer [REDACTED] returned back to the area of North Howard Avenue and Tallmadge Road. A short time later, both officers stated that they observed Walker's vehicle back in the location of North Howard Avenue and Tallmadge Road.



This fact is confirmed by Walker's device locations. It appears that when Officer [REDACTED] and Officer [REDACTED] decline to follow Walker's vehicle onto Route 8 south, Walker returns to the area of North Howard Avenue and Tallmadge road in approximately eight minutes. The below map indicates Walker's device locations after Officer [REDACTED] and Officer [REDACTED] declined to follow his vehicle onto Route 8 south (Figure 6).

Also, Walker's device is in the area of the Akron Police Department on several occasions in the hours leading up to the shooting (Figure 7).



SA Momchilov created a video using Google Earth Pro that illustrates Walker's device locations from June 26, 2022, 10:06:15 PM, through June 27, 2022, 12:36:33 AM. SA Momchilov also incorporated the time and locations of Walker's one phone call, Google location search, New Franklin Police pursuit information and the offline LEADS search. It should be noted that according to The Maps Display Radius field, it reflects an estimated uncertainty value regarding the reported coordinate.

The video created by SA Momchilov was placed onto a CD; the CD was placed into the item section of the physical case file, labeled as Item Q.

#### Case Synopsis:

Officers with the Akron Police Department were engaged in a vehicle pursuit and the subject reportedly fired a firearm. The subject fled from the vehicle near the E. Wilbeth Rd. entrance to Bridgestone, and Officers engaged in a foot pursuit with the subject. During the pursuit, the subject was reportedly observed reaching towards his waistband. It was reported that eight Akron Police Officers fired their firearms while in the parking lot, striking and killing the subject. Ohio BCI was requested to investigate the Officer Involved Critical Incident. (Information obtained from SA Soroka's Scene Processing Report)

#### Analysis Requested:

BCI Special Agent Momchilov requested the analysis of Google location records in order to provide a report displaying location data for the target on June 25-27, 2022. Special Agent Armstrong provided the records for analysis.
