Narrative:

On February 9, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matthew Armstrong (Armstrong) met with Southwest General Police Department Chief Tristan Harker (Harker). Chief Harker indicated the requested records were available for pickup, and Emergency Department Exam Room 3 was vacant and available to be photographed.

At approximately 1230 hours, SA Armstrong received the following documents:

- Video recordings
- CAD reports
- Audio recorded phone calls and radio transmissions
- EMS run report
- Involved officers' personnel files
- Involved officers' training files
- SGPD Response to Resistance policy and Patient Restraint policy
- Reports documenting the department's prior encounters with Bryan Bailey (Bailey).

Chief Harker included an index of the records provided. It has been uploaded to Matrix and attached to this report. The audio and video recordings were provided on a thumb drive, which has been stored in the BCI SIU case file as Reference Item A.

While present, Chief Harker escorted SA Armstrong to the ambulance bay where Mr. Bailey arrived. SA Armstrong photographed the ambulance bay, the location of the only security camera that captured Bailey's arrival, the area through the emergency department leading to exam room 3 and Exam Room 3, where the incident occurred. The photographs have been uploaded to Matrix and stored on a CD in the BCI SIU case file as Reference Item B.
