2024-1755 Officer Involved Critical Incident - 4500 Block of Sullivant Ave, Columbus, OH (L)

On June 11, 2024, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Columbus Police Department (CPD) to investigate an officer involved critical incident. As part of the investigation, Crime Scene Technicians (CST) Amy Gill and Holly Ryczek responded to CPD Substation 10 to process the involved officers.

CST Gill arrived at the substation where the involved officers were located at approximately 0245 hours. She was advised that five offices had discharged their weapons and one additional officer had witnessed the incident. All officers were observed to be in their agency issued uniforms, and dressed as they were at the time of the incident with the exception that their body worn cameras had been removed for video download. The specifics of each officer are detailed below.

- discharged his service weapon, a Smith and Wesson M&P 9, M2.0 semi-automatic pistol with serial number attached Streamlight TLR-1 flashlight. The seated magazine contained 8 cartridges and one cartridge was removed from the chamber. The firearm, magazine, and cartridges were packaged together as item 1.
- Wesson M&P 9, M2.0 semi-automatic pistol with serial number with an attached Streamlight TLR-1 flashlight. The seated magazine contained 10 cartridges and one cartridge was removed from the chamber. The firearm, magazine, and cartridges were packaged together as item 2.
- discharged his agency issued taser during the incident. The yellow and black taser, model Taser7, with serial number along with the battery and spent cartridge were packaged together as item 4. Officer Dorsey also discharged his service weapon, a Smith and Wesson M&P 9, M2.0 semi-automatic pistol with serial number with an attached Streamlight TLR-1 flashlight. The seated magazine contained 15 cartridges and one cartridge was removed from the chamber. The firearm, magazine, and cartridges were packaged together as item 3.

- discharged his service rifle during the incident. CST Gill was informed that his rifle remained on scene, secured inside a CPD Cruiser. Officer Boehm's duty pistol, along with his spare pistol and rifle magazines were photographed for documentation purposes only.
- discharged his service rifle during the incident. CST Gill was informed that his rifle remained on scene, secured inside a CPD Cruiser. Officer Bell's duty pistol, along with his spare pistol and rifle magazines were photographed for documentation purposes only.
- Officer Adam Minor (#3298) was a witness to the shooting. Officer Minor did
  not discharge his weapon. He was photographed along with his duty pistol for
  documentation purposes only.

CST Gill cleared the substation at approximately 0335 hours and returned to the main shooting scene. At 0541 hours, CST Gill received all evidence collected from Scene 1 from Special Agent (SA) Chung. At 0625 hours, CST Gill placed all items collected from Scene 1 and Scene 2 in the BCI Crime Scene Unit temporary evidence locker located in London, Ohio to be retrieved by SA Chung at a later time.
