Narrative:

On Monday, October 27, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agents John Tingley (SA Tingley) and Doug Burke (SA Burke) conducted a second neighborhood canvass in the area of 1642 Cherry Lane, Findlay, Ohio. The purpose for the canvass was to identify and interview potential witnesses to the officer-involved critical incident (OICI) that occurred at 1642 Cherry Lane, Findlay, Ohio on Wednesday, October 22, 2025.

The following is a synopsis of the locations checked, and the interviews/statements given and questions answered by the subjects interviewed and is not a word for word translation of the interview or statements given.

During the neighborhood canvass, Special Agents Tingley and Burke made or attempted contact with the residents at the following addresses:

1648 Cherry Lane

Agents knocked on the front door facing Cherry Lane (1335 hours), a second door in an alcove also facing Cherry Lane (1339 hours), and a rear door (1341 hours). There was no answer at any of the doors. Door hangers were left at each door with SA Tingley's business card attached with SA Tingley's contact information listed, requesting the resident/s to contact SA Tingley. It could not be determined at the time if this was a single residence or a multi-unit residence/apartment.

On Monday, November 3, 2025, at 0703 hours, SA Tingley received a phone call from Brianne Greer (Greer) who stated that she resides at 1648 Cherry Lane. SA Tingley asked Greer if she had heard or seen anything related to the OICI. Greer replied that she was not home at the actual time of the incident. SA Tingley then inquired as to whether the residence was a multi-apartment complex or a single residence. Greer replied that the residence is a single home with three separate entry doors.

On Thursday, November 6, 2025, at approximately 0844 hours, SA Tingley contacted Greer by phone. SA Tingley verified with Greer that she was not at home at the time of the OICI. SA Tingley then asked Greer if she had any cameras on her residence that would have shown anything that happened at the scene of the OICI and Greer replied that she did not. This interview was audio-recorded and is stored in AXON JUSTICE as Reference Item H.

1649 Cherry Lane

On October 27, 2025, at approximately 1344 hours, Agents contacted Dorothy Weaver (Weaver) at this residence. SA Burke asked Weaver if she saw or heard anything regarding the OICI. Weaver stated that an officer contacted her and asked if she had reported shots fired. Weaver responded to the officer that she had not heard any shots fired or called regarding shots fired. At that point, the officer began walking over towards other officers who were at 1642 Cherry Lane. Weaver then said that pretty quickly, she heard shots fired (01:12 mark of the recording). Weaver continued and said that a large tree in her front yard blocked the view of the front door to the residence at 1642 Cherry Lane. However, she did witness an officer move behind a tree at 1642 Cherry Lane and she then saw that officer fire multiple shots (01:24 mark of the recording). SA Burke asked Weaver how many shots she had heard, and Weaver responded that she had heard three (3) to six (6) shots. The interview then concluded. This interview was audio-recorded via AXON Capture and is stored in AXON JUSTICE as Reference Item H.

1707 Cherry Lane

On October 27, 2025, at approximately 1354 hours, Agents contacted Ali Cox (Cox) at this residence. SA Burke asked Cox if she saw or heard anything regarding the OICI. Cox stated that she was not at home at the time of the incident but that she was talking with her sister by phone her sister told her that she had heard shots and then saw a bunch of cops nearby (the sister, Lily Cox, was interviewed by SA Rammel and SA Tingley on October 22, 2025). Cox then returned home and saw an ambulance which left after about ten (10) to fifteen (15) minutes. The interview then concluded. This interview was audio-recorded via AXON Capture.

The two interviews conducted were audio-recorded. The recordings are stored in AXON JUSTICE as Reference Item H. Please refer to the reference item for any additional details.
