NARRATIVE

FELONIOUS ASSAULT // IMPROPER DISCHARGE OF FIREARM INTO HABITATION

On Thursday, January 18, 2024, while assigned to zone-car 4A11, while in the company of my partner P.O. Vardell #2554, we received a code-1 radio assignment to respond to ██████ Canton Ave. to assist units on scene in C/W Cad #2024-015839 Felonious Assault. Below are the facts of the assignment.

Upon our arrival my partner and I was advised to handle the finishing of the crime scene log. I was approached by Sgt. Gomez #9135 stating another house was discovered that was shot into at the address of ██████ Spafford St. I then walked over and conferred with (VIC) ██████ that stated he heard gunshots around 0300 hrs but did not notice his house was shot into until this morning. Mr. ██████ residence had to bullet holes through the exterior wall. The first bullet hole went through the dining room wall and into his bedroom damaging his mattress. The second went through his bathroom damaging the bath tub.

Mr. ██████ stated that he was asleep in the basement at the time of the shooting and was the only person inside the home. SIU was advised and on scene ok per Sgt. Gomez #9135 for photos and evidence collection.
