Narrative:

On August 20, 2022, at 0915 hours, the Ohio Bureau of Criminal Investigation (BCI) was requested by Sheriff Shaffer of the Knox County Sheriff's Office (KCSO) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved shooting which occurred in the area of 15266 Gilchrist Road, Mt. Vernon, Ohio. BCI Special Agent (SA) John Tingley responded to assist, arriving at approximately 0945 hours. Other Special Agents responding from the BCI Special Investigations Unit were: Butterworth, Collins, Russell, Gore, Wieging, Poole, Horn, Doolittle, Shea, Scale, Momchilov, Lieber, Banský, Goudy and Clar. Also responding were Special Agent Supervisors Barbeau, Posten and Stranahan, as well as Special Agent in Charge Davis. Additionally, BCI Crime Scene Unit Special Agents Chung, Holcomb, Taylor and Staley were requested to process the scene by documenting and collecting pertinent evidence.

The shooting incident involved two subjects, Randy Wilhelm and Bradley Wilhelm, and members of the Delaware County SWAT Team. The incident resulted in the deaths of both Randy Wilhelm and Bradley Wilhelm.
