Narrative:

On Monday, May 1, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) received the Autopsy Report from the Trumbull County Coroner's Office. The autopsy was completed by Doctor George Sterbenz, M.D., Forensic Pathologist and Deputy Coroner. The records requested included any reports pertaining to the March 21, 2023, officer-involved shooting, except for any statements made by the involved officers.

The information deemed to be the most relevant to this inquiry is summarized below for the convenience of the reader. However, as the author is not a doctor, it is suggested that the Autopsy Report be viewed in its entirety to ensure no pertinent information has been omitted or described out-of-context.

SA Goudy reviewed the documents and noted the following:

The injuries described within the report appeared consistent with the injuries sustained from gunshots. No suspicious injuries to other parts of the body were identified.

Cause of Death: Multiple gunshot wounds

Manner of Death: Homicide






