**Details:**

On July 5, 2022, at approximately 1135 hrs., S/A Justin Soroka retrieved the items Akron Police had collected on the date of the incident from temporary evidence locker #10. S/A Soroka had previously taken custody of the items from Detective Sergeant Tony Starvaggi on June 28, 2022.

Item #1 was a cartridge case recovered by Akron Police. It was removed from its packaging, which was a sealed paper bag inside of a sealed envelope, and photographed. The cartridge case was marked with the headstamp "SIG 9mm Luger". The cartridge case was repackaged in its original packaging, then placed in an envelope, which was sealed and initialed by S/A Soroka.

Akron Police had collected and packaged items from the involved officers. In reviewing Akron Police's inventory sheet, it appeared that an individual evidence number had been created for multiple items placed in a single package. For example, a firearm, its magazine, the cartridges in the magazine, the cartridge from the chamber, and the attached tactical light were all assigned a number. As a result, all items contained in one firearm's box had five separate item numbers created and affixed to the box. In this case, S/A Soroka documented the items contained within the package, and assigned it one Matrix number. Individual Officers' spare firearms magazines were packaged separately. After they were documented, S/A Soroka packaged them together by Officer and assigned them one Matrix number.

The items were returned to temporary evidence locker #10 at the Ohio Bureau of Criminal Investigation in Richfield.
