Narrative:

On November 20, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Armstrong (Armstrong) received the results of the analysis for Matrix evidence Item #10, an Apple iPhone 13, Model A2482. The analysis was completed by BCI Cyber Crimes Certified Forensic Specialist (CFS) Natasha Branam. A copy of her forensic analysis report has been attached to this report. The data extracted from the devices was stored on a thumb drive in the BCI SIU case file as Reference Item D.

The data extracted from the device was organized in a Cellebrite Reader Report. SA Armstrong utilized Cellebrite Reader to view the data and noted the following:

The cell phone appeared to belong to Thomas Nock as the Apple ID associated with the device was nock430@icloud.com and the owner's name associated with it was Thomas Nock. Additionally, the device name was Thomas's iPhone.

Summary:

On November 17, 2023, Special Agent Matthew Armstrong of the Ohio Bureau of Criminal Investigation received a warrant to search the contents of the below listed item. This item was to be analyzed for evidence relating to the crimes of Felonious Assault and Murder regarding the subject, Thomas Nock.

Submitted Items:

010 – Mobile Phone – Apple iPhone 13 – A2482

Details:

Item 10: Item 10 is an Apple manufactured mobile phone model A2482 (iPhone 13). The International Mobile Equipment Identity (IMEI) numbers associated with Item 10 are 353207334120429 and 353207331200562 and the serial number is WXXVCX3YR6. Item 10 has an advertised internal storage capacity of 128 Gigabytes (GB), 256 GB, or 512 GB and is not capable additional storage. Item 10 is locked with an unknown passcode. The device was connected to a forensic tool capable of determining the passcode on the device; however, this model is not supported at this time. A partial file system extraction was obtained from this device and it was then loaded into Cellebrite Physical Analyzer, a software package that converts that data to an easily readable format.

Item 10a: Item 10a is a Verizon branded Subscriber Identity Module (SIM) card bearing the Integrated Circuit Card Identifier (ICCID) 8914800009452670740.

Findings:

Item 10: Due to the phone being locked and only being able to extract a partial file

system from the device; it is recommended additional information be obtained from service providers. The Apple ID associated with Item 10 is nock430@icloud.com. The owner name associated with Item 10 is Thomas Nock and the device name is Thomas's iPhone. Attachment A contains one (1) Cellebrite UFDR file. In order to view the content of the UFDR file double-click the CellebriteReader.exe and the UFDR will auto populate. Once the Cellebrite Reader is open the content can be examined and any additional reports can be generated.

Item 10a: The phone number associated with Item 10a is 216-314-7406.

Conclusion:

Attachment A can be found upon the thumbdrive (provided by the agency), provided for further review by the case investigator.

Due to applied security features, a full examination was not able to be performed on Item 10. Item 10 can be re-examined upon acquisition of the proper passcode.
