SALARY—CITY COUNCILMAN MAY BE SECRETARY OF BOARD OF TRUSTEES OF FIREMEN'S PENSION OR POLICE RELIEF FUND AND RECEIVE COMPENSATION FOR BOTH POSITIONS.

SYLLABUS:

Where a councilman of a city which has no charter, who is a member of the board of trustees of the firemen's pension or police relief fund, has been elected secretary of such board, he may receive such compensation therefor as may be fixed by said board, in addition to his salary as councilman.
