Narrative:

On October 22, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) completed a review of the video captured from the body-worn camera (BWC) of Officer Brian Ondercin (Officer Ondercin) during this incident.

Amped Replay was used to review the video.

SA Valente made a working copy of the BWC video and placed the copied video in a folder on his BCI issued laptop. The working copy of the videos was used for the review.

The video began after the shooting occurred. At the time the recording began, Officer Ondercin's BWC was pointed in the general direction of Ferrel Thomas, Genisis Thomas, and Jacquelyn Fortson, as they talked near the roadway in front of their home. During the conversation, Genisis Thomas and other family members attempted to convince Ferrel Thomas to leave the scene. Ferrell Thomas, father of the subject, appeared distraught and told his family he wanted to stay at the scene to be with his son.

Ferrell Thomas briefly yelled at the police for telling him to exit the home.


