



MESSAGE of APPRECIATION

Detective Melissa A. Boyes sent a message of appreciation for your actions on May 11th, 2024. She writes, "I just wanted to let you know how much I appreciate everything you did on scene on Rafael Gomez-Perez (felony theft and B&E from Lorenz/Anna). It made my Sunday Processing so much more smooth than the average work day. Sunday Processing cases are always a little tight because they have been presented that day, sometimes without all the needed information. In this case, I had all the needed information in the original report and I did not have to go searching for it or waking victims up at 7am on a weekend. You two really did more than the average officer would have done with getting video and noting in the report what property belonged to what person. The property screen in MIS reads so much more clean when that type of information is entered.

Keep up the good work and keep being training officers so new people learn the correct way to do calls like this."

WRITTEN COMMENDATION

Sergeant Philip P. Watts commended you on your compassion, desire to serve the public, and dedication to your duties on January 26th, 2024. You responded to Montgomery County Sheriff's Office's request for assistance due to a prisoner escape. This was a rapidly evolving situation as a suspect violently assaulted a MCSO Deputy and stole their duty weapon. The suspect, while trying to avoid being captured, attempted to break into one occupied residence before successfully breaking into 130 Squirrel Road. It was quickly determined that immediate entry into the house was required to preserve life and apprehend an armed and dangerous felon. Your quick and decisive actions to enter the residence to conduct a hostage rescue resulted in scene security, ensuring no further innocent bystanders were placed in harm's way. In your actions to intervene, you knowingly placed yourself in harm's way while facing an armed and dangerous suspect.

9-19-2022

WRITTEN COMMENDATION

Sergeant James M. Campolongo commended you for your quick response, attention to detail, and pursuit of justice during a complaint on September 19, 2022. You responded to the area of Salem Avenue and Lexington Avenue at the request of Officer Wayne M. Hammock, who needed assistance with a wanted subject, Sparkle Colquitt, who was armed with a knife. When you arrived, you found Ms. Colquitt walking westbound on Lexington Avenue and turning north onto Meredith Avenue, with Officer Hammock and [REDACTED] walking behind at a safe distance. You observed Ms. Colquitt with a knife in her hand and she was not obeying commands given by Officer Hammock. You and Officer Hammock remained at a safe distance following Ms. Colquitt onto Meredith Street. She was tased a third time by Officer Jared M. Burson which had the desired effect and Ms. Colquitt dropped the knife. You along with other responding officers closed in on Ms. Colquitt and were able to safely take her into custody and arrest her on several charges. Your efforts in this matter were highly professional and reflect well on you and the entire Dayton Police Department.

LETTER of APPRECIATION

Lawrence Lindsey, a retired US Army veteran, sent a Letter of Appreciation to you which stated in part he was grateful for your assistance in moving his broken-down car out of the street. He stated the situation was not good with heavy traffic. He further stated, "I think its my civic duty to recognize the police department for the that they do."

WRITTEN COMMENDATION

Sergeant Jonathan Sopczak commended you for your actions on May 17, 2021, when you assisted Officer Tony Murphy at N. Main Street and W. Mumma Avenue on a medical emergency. The driver of a vehicle was having an allergic reaction and had administered an EpiPen dose. You monitored her and awaited medics. When you noticed her condition deteriorating, you and Officer Murphy moved her to a cruiser and transported her to the nearest hospital. You also coordinated

with other officers to have the patient's vehicle brought to the hospital save her from her vehicle being towed.

10-19-2020 WRITTEN COMMENDATION

Sergeant Jonathan Sopczak commended you for your actions on September 14, 2020, after you and your partner, Officer Kyle Harris, were made aware of information involving a suspect vehicle used in a felonious assault that resulted in the victim being shot multiple times. During your shift, you located the vehicle which abruptly pulled into a driveway and the driver fled. After a short foot pursuit, the suspect was apprehended and transported to the Safety Building where he was interviewed by homicide detectives. The suspect was subsequently booked for felonious assault and drug charges.

9-14-2020 WRITTEN COMMENDATION

Sergeant Alexander Magill commended you for your actions on July 5, 2020, after officers were dispatched to 4432 Eichelberger Avenue on a welfare check involving a potentially suicidal male with three children. While attempting to take the male into custody for a capias, the front door was forced open and the male barricaded himself in a bedroom with the three children. When the male began talking about ending his life, entry was forced into the bedroom and using sound tactics, the three children were removed unharmed.

5-11-2020 WRITTEN COMMENDATION

Sergeant Jonathan Sopczak commended you for your actions on May 11, 202, after you were made aware of a lock-up broadcast for kidnapping in which Albert Redmond was the suspect using a 2001 White Chevy Tahoe. During your shift, you and your partner, Officer Kyle Harris drove passed Redmond's house and observed the Tahoe in front and Redmond looking out the window. You commanded Redmond to exit the house and he complied. He was taken into custody without incident and gave consent to search the residence.

09-20-19 WRITTEN COMMENDATION

Sergeant Creigee Coleman commended you for your actions on August 11, 2019, after you and Officer Kyle Harris were dispatched to 5510 Madison Woods on a Domestic Violence. Comments indicated the victim's child had been taken away by the child's father. After taking the initial report you continued to ask questions and obtained information that the suspect could be heading to his girlfriend's apartment. You and Officer Harris went to the apartment and located the suspect's vehicle. After contacting the apartment manager, you entered the apartment, located the child and arrested the suspect. The suspect was subsequently charged with Kidnapping and Domestic Violence.

3-27-18 WRITTEN COMMENDATION

Sergeant Andrew Zecchini commended you for your actions on March 27, 2018 when you and several officers took it upon yourselves to provide extra patrol through Hilltop Apartments where a suspicious vehicle drew your attention. The vehicle drove out of the area at a high rate of speed. After making a traffic stop, one of the two occupants was found to be CIRVG member. One handgun was recovered from the passenger as well as being in possession of drugs. Two more firearms were recovered from under the driver and passenger seats. A large amount of drugs was recovered from the center console. Both suspects confessed to the guns and drugs.

Sergeant John Garrison commended you for your actions on March 11, 2019, after VOU Detective Nathan Curley disseminated surveillance video and stills of two suspects who attacked an 84 year old female at 2020 Burroughs Road the previous day. Within two hours of starting your shift, you located one of the suspects in the area of W. Fairview and Rugby Road. Detectives responded and interviewed the suspect which resulted in the identification and location of the second suspect.
