Narrative:

On Friday, December 6, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) compiled background information on Jazmir Tucker (Tucker), a subject involved in the incident on November 28, 2024. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit, Akron Police Department, and the Summit County Juvenile Court.

SA Lieber reviewed the information and noted the following:

Prior Police Encounters:

Tucker was involved in an incident on September 20, 2024, at North High School (Akron PD incident #2024-00113551). According to the report, Tucker and another juvenile male were charged with disorderly conduct.

Computerized Criminal History (CCH) and/or Court Records:

On January 17, 2025, SA Lieber received records from the Summit County Juvenile Court. The records consisted of 5 pages (including fax cover sheet and records request).

I, Ofc. Johnson, was working as the SRO at North CLC. At around 1115 hours I started toward the lunch room to work lunch security.

Around 1121 hours, I could see the suspects, Dae'Shaun Wade and Jazmir Tucker in the south part of the cafeteria. I could see Wade and Tucker start getting in each other's face and begin a verbal fight. I ran over giving verbal directions in an attempt to de-escalate Wade and Tucker. I grabbed Wade and told him the fight was over and to stop. As I escorted Wade away, I told Tucker to back off and go away. Wade tried to push me away and walk toward Tucker in an attempt to fight him. I continued holding on to Wade and told him again, it was over and he needed to stop. Wade tried to push me out of the way a second time. Due to Wade trying to get past me to fight Tucker, I performed a take down move on Wade and placed him on the floor. Wade was placed in hand cuffs. As I was apprehending Wade, Tucker came over to us and stood over us. I was concerned that Tucker was going to try to stomp or kick Wade. School safety team intervened and pulled Tucker away before he could inflict any harm. Wade was taken out of the cafeteria and placed in room 108.

I advised Wade on his Miranda warnings. Wade stated Tucker was being disrespectful in the hallway outside the cafeteria. Wade and Tucker got into a verbal fight. Wade stated I came and started to separate them. Wade saw Tucker drop his backpack and that's what made Wade try to push past me. Wade stated I took him to the ground and placed him in handcuffs.

Tucker was no longer on scene and I was unable to interview him.

In the Lunch room, the fight was seen on camera. In the video you can see both Wade and Tucker get into a verbal fight. I came in to separate both Wade and Tucker. As I was separating Wade and Tucker, Tucker pushed Wade. Wade tried to push past me to get to tucker. I grabbed Wade and begin to walk backwards with him to stop the fight. Wade is observed trying to push past me a second time. I do a take down move on Wade and take him to the floor. Tucker came over and stood over top of Wade and placed his right foot on Wade's right hip. Tucker and Wade were escorted out of the lunch room.

Both students were charged with disorderly conduct. Both students parent's were contacted and advised of this incident and the charges. Both students were sent home to their parents. Sgt. White was notified of this and was on scene. Wade did not report any injuries and EMS was not called. I

The Ohio Bureau of Criminal Investigation (BCI) is investigating an incident (Case #2024-3775) that occurred on November 28, 2024. The incident involved a confrontation between Akron Police Department officers and Jazmir Tucker (DOB 03/11/2009). The incident resulted in Jazmir Tucker's death. During the investigation it was learned that Tucker may have been charged with Disorderly Conduct stemming from an incident that occurred on September 20, 2024, at the North High School in Akron, OH. BCI is making a formal request for any records the Court may have regarding this incident as well as any other incidents involving Tucker that occurred between November 28, 2023 to November 28, 2024.

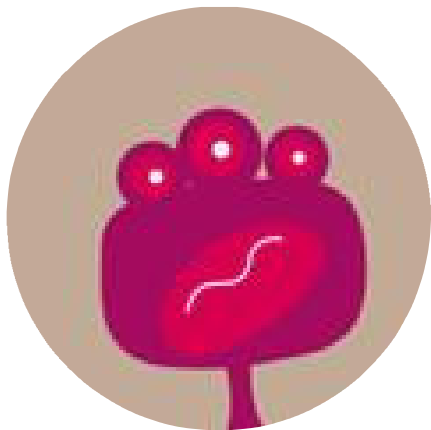

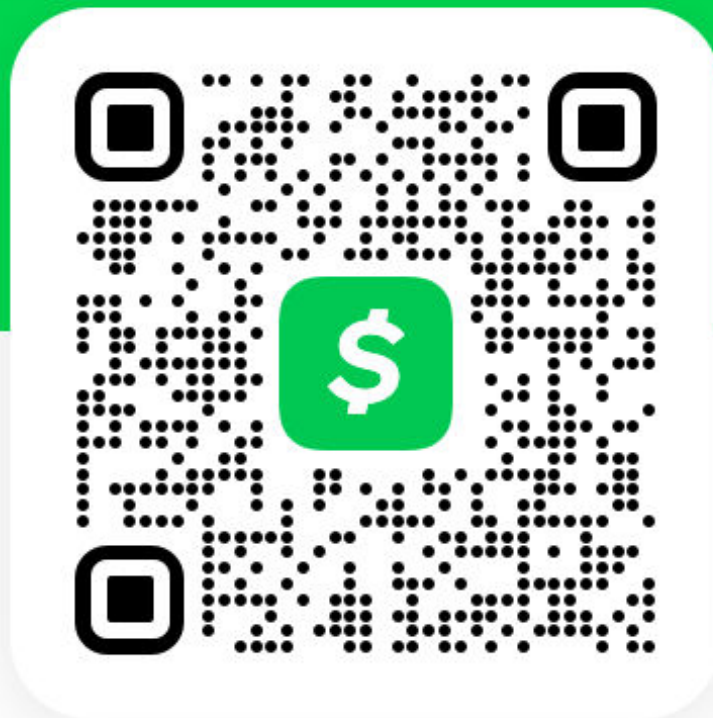


