Narrative:

On Thursday, November 13, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (SA Tingley) compiled background information on Robert Norton (Norton), a subject involved in the incident on October 22, 2025. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Findlay Police Department.

SA Tingley reviewed the information and noted the following:

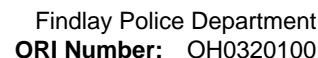

TIRE SLASHED

Initial Report Slashed Tires

On 05-06-04, I was dispatched to 1640 Hilton Ave. regarding a damaged vehicle. I spoke with Tara Hardesty. Tara drives a tan 1999 Nissan Altima reg. plate BX72UH, owned by her father, Edward Hardesty. According to Tara, the vehicle was unlocked parked N/B in the driveway located South of her residence. The vehicle was parked in that location from approx. 1930 hrs on 05-05-04 until approx. 0730 hrs on 05-06-04. While the vehicle was parked, approx. 8 CD's were stolen from inside the vehicle and the right rear Firestone Firehawk FTX tire was "slashed" with an unknown object.

After leaving Tara's residence I observed that several other vehicles in the area had been damaged. I observed a white 1988 Cadillac Sedan de Ville reg. plate SLE4, parked W/B in the driveway East of 1018 Cherry Ln. The right front and right rear Goodyear Regatta tires had been "slashed". The owner, Shelia Evans was notified.

I observed a green Ford Windstar reg. plate BQ84LE, parked W/B in the driveway East of 1026 Cherry Ln. The right rear Michelin Weatherwise tire had been "slashed". The red 1990 Jeep Comanche reg. plate BQ60LE parked W/B behind the Windstar was also damaged. The right rear Guardsman Plus tire on the Jeep was "slashed". The owner of both vehicles, Hugh Ferguson was notified.

I observed a white 1992 Dodge Caravan reg. plate AFL2783, parked N/B in the driveway South of 1642 Cherry Ln. The right front and right rear Cooper Lifeline Classic II tires had been "slashed". The owner, Robert Norton was notified.

There are no witnesses or suspects at this time.

Dispatch Narrative TRANSFERRED FROM CAD

CREDIT CARD WAS MISUSED
WAS USED AT WALMART IN FARMINGTON, NY AND RADIO SHACK

Initial Report

I was dispatched to 1642 Cherry Ln on a report of misuse of a credit card. Upon my arrival I spoke with Robert Norton. Robert said on Sunday 02/06/2010 he went to IHOP for breakfast with his wife and some friends. Robert said they usually go to IHOP every Sunday for breakfast.

When Robert attempted to pay for his meal he discovered that his credit card would not be accepted. When he got home he attempted to call Visa to find out why his card wouldn't work. Visa was closed and he was unable to make contact with anyone. Today he called Visa and spoke with the fraud division. Robert said on 02/05/2010 someone had purchased \$324.79 worth of merchandise at WalMart in Farmingdale NY. Visa thought the purchase was suspicious and cancelled his credit card. A short time later the card was used again at a K-Mart in Farmingdale for the amount \$225.86. The purchase was rejected. Late in the day the card was again used to attempt to make two purchases at a Radio Shack for \$6.00 and \$256.33. Both of those were rejected.

Robert said he did some on line research and discovered all three stores are on Long Island NY. The fraud division for Visa said the person who was using the card had a card with his number on it. They believe the subject had made a fake card using a valid number. Robert said Visa cancelled the credit card and advised him they would mail him a new card in a couple of days.

Robert spoke with his friend who they had breakfast with and told him about this situation. The friend told Robert that he had the same thing happen to him a month ago. Robert said this made him think that maybe someone at IHOP was writing down credit card numbers of their customers. Robert said he had nothing to prove this but he thought it was suspicious that both he and his friend only use their cards sparingly and IHOP is one place where both cards have been used.

Neighbor Threatened Dogs

Initial Report

On 05-04-2016, I was dispatched to speak to a subject about threats being made towards her dogs. The subject received a note making threats. I spoke to all parties involved.

Investigative Notes

On 05-04-2016, I was dispatched to 1649 Cherry Ln. for threats being made towards barking dogs. I spoke to Maria Schneider about this incident.

Maria said that her aunt, Dorothy Weaver, got home yesterday and observed a note taped to the garage door. The note said "Dead Dogs Don't Bark". Dorothy was advised by a neighbor that Robert Norton was responsible for the note. Robert lives at 1642 Cherry Ln.

Maria said that Dorothy went over and asked Robert if he placed the note on the garage door. Robert admitted to Dorothy that he placed the note on the door. I asked Maria what she wanted done. Maria said they don't want charges, they just want a report on record in case something happens to the dogs. I told Maria I would go over and talk to Robert. I also told Maria that there is an ordinance against barking dogs and they might want to find a solution. Maria said they are trying to fix the problem.

I went to 1642 Cherry Ln. to speak with Robert. I advised Robert why I was there and asked him about the note. Robert admitted to placing the note on the garage door. I told Robert that was not the proper way to handle the situation and he should have called the police if he has a barking dog complaint. Robert was very agitated and continued to yell. Robert stated that the note was not a threat to kill the dogs, he was just telling her to take care of her dogs. I read the note to Robert and advised him that it is a threat to kill the dogs and no where in the note does it say "just take care of your dogs". Robert continued to disagree with this point. I advised Robert not to make any more threats and to call the police if he has a complaint.

I went back and advised Maria that I talked to Robert. I also advised her that she might want to take care of the barking dogs, because Robert more then likely will be calling the police to report the barking. The note left was collected and included with the report.
