### Narrative:

On Sunday, July 13, 2025, at approximately 1920 hours, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman interviewed Eric Schneider. Mr. Schneider identified himself as the son of Ronald Kerr and the stepson of Consuelo Kerr.

The following summary of the interview highlights the key points the author deemed most relevant, although it does not provide a verbatim account. Additionally, this report was placed in a chronology to aid in the overall understanding of the information elicited during the interview and may not reflect the actual interview sequence. For further details, please refer to the interview recording.

Mr. Schneider stated that he learned of all of the events that had transpired after the fact. He advised that he is Ronald's eldest son. He stated that Ronald met Consuelo in Michigan, where they both used to reside. He stated that they both eventually moved to Middletown. He said that "She [Consuelo] did him wrong a lot." He elaborated that Consuelo was threatening to leave Ronald.

Mr. Schneider stated that he last spoke with Ronald a "couple of days ago." He stated that Ronald seemed "down and kind of flustered." He stated that Ronald likely abused some of his medications. He stated that Ronald told him that he had been arguing with Consuelo and was uncertain about what to do.

SA Seitzman inquired if he knew Ronald to be violent. He recalled one incident when he was a young child where Ronald hit a wall during an argument with his biological mother. He was unable to remember any other instances of possible violence.

Mr. Schneider stated that Ronald was in poor health and was a double amputee due to an infection. He stated that he lost his first leg approximately five to eight years ago and then later lost the second one due to inactivity. He further stated that his father suffered from

## depression.

Mr. Schneider stated that his father used to work at JT Express trucking in Monroe, Ohio. SA Seitzman inquired if Ronald was a military veteran. Mr. Schneider clarified that Ronald was never a military veteran, despite his tendency to lie about military service.

The interview concluded at 1929 hours. It was recorded via a body-worn camera. The footage was stored in the Evidence.com case within the folder labeled "Reference Item M - Interview of Eric Schneider."
