Narrative:

On Monday, January 30, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Todd Clark (Clark) reviewed police reports provided to SA Charlie Snyder on December 28, 2022, by the Cuyahoga Falls Police Department (CFPD). The reports were provided in a 45-page PDF file titled, "Z.Zoran Reports." SA Clark reviewed the reports and noted the following:

Case Number: 2022-00037262

Zachary Zoran (Zoran) was listed as a suspect in an Intimidation and Aggravated Menacing report dated December 26, 2022. Sherry McCrossin (McCrossin) was listed as a victim. McCrossin reported she received multiple threats over Facebook from her nephew (Zoran). McCrossin said Zoran threatened to shoot her and murder her in cold blood. McCrossin indicated she believed Zoran was using drugs (methamphetamine) and that was the reason why he was acting aggressively towards her and her family. McCrossin stated Zoran wanted her to hand over his son to him. Zoran was trying to obtain custody of his son. McCrossin did not want to pursue charges against Zoran.

Case Number: 2022-00037213

Zoran was listed as a suspect in an Intimidation and Aggravated Menacing report dated December 25, 2022. Pamela Stratford (Stratford) was listed as a victim. Stratford reported her son threatened to kill her through voice and text chats on Facebook Messenger. Stratford believed Zoran was under the influence of methamphetamine and may be schizophrenic. Stratford reported seeing a Facebook post in which Zoran referenced having multiple weapons. Stratford reported it appeared he injured his hand during an altercation and was discharged from the hospital. A warrant and TPO were issued against Zoran.

Case Number: 2020-00008198

Zoran was listed as a suspect in a Violating a Protection Order report dated March 18, 2020. Stratford was listed as the victim. Stratford reported Zoran called her on numerous occasions and wanted money, which she received from Zoran's SSI check. Zoran told Stratford if he did not receive his money, "You're going to pay for that," and if he doesn't get visitation, "She would be sorry."

Case Number: 2019-00028753

Zoran was listed as a suspect in a Violation of a Protection Order report dated September 28, 2019. Stratford was listed as a victim. Stratford reported Zoran sent messages to Stratford through text messaging and Facebook. Stratford said the messages were not threatening, but Zoran was not supposed to be sending them.

Case Number: 2019-00027766

Zoran was listed as a suspect in a Violation of a Protection Order report dated September 19, 2019. Stratford was listed as a victim. Zoran contacted Stratford and claimed his son, Gabriel Zoran, was in danger. Stratford claimed Zoran suffered from multiple mental illnesses.

Case Number: 2019-00023878

Zoran was listed as a suspect in a Violation of a Protection Order report dated August 15, 2019. Stratford was listed as a victim. Stratford reported Zoran called her and complained about being arrested for an incident which took place on August 13. Stratford indicated Zoran did not threaten her. CFPD contacted Zoran and advised him to stop contacting Stratford. Zoran was upset and argumentative about being told not to contact Stratford.

Case Number: 2019-00023565

Zoran was listed as a suspect in a Disorderly Conduct report dated August 13, 2019. Stratford advised CFPD that Zoran harassed her numerous times. CFPD responded a second time in connection with this incident. Zoran was arrested after a verbal altercation with CFPD officers. During the arrest, Zoran resisted arrest and fought with CFPD officers.

Case Report by Officer Hudak

I was dispatched to take a phone report of a menacing. I made contact with the caller/victim, SHERRY MCCROSSIN. MCCROSSIN stated that this morning around 9 am, she received various audio messages, via Facebook messenger, from her nephew, ZACHARY ZORAN. MCCROSSIN stated that in those messages, ZORAN was making various threats to kill her and her family if she did not hand over his son to him. MCCROSSIN stated that, yesterday, ZORAN was just arrested for similar threats against his mother, who is her sister. She stated that the threats have all stimulated from, ZORAN not having custody of his son. MCCROSSIN also stated that, ZORAN is an avid drug user and she believes that he is high on Meth at this time.

MCCROSSIN did email, the audio files of the messages and they were tagged into the public drive. I did listen to the messages and you can hear, ZORAN stating that if his son is not returned, that he is going to shoot everyone he sees. Inside of the messages, he also addresses, MCCROSSIN by her name and stated the next time he sees her, he was going to shoot her and murder her in cold blood.

MCCROSSIN also stated that she was unsure if these threats were valid at this time, seeing that the aggressive behavior usually stems from, ZORAN'S drug use. MCCROSSIN states that once ZORAN calms down and comes off of whatever drug he is using, she believes that it is possible that he may calm down. MCCROSSIN did state however that during the time that the messages were sent, she felt that it was a possibility that ZORAN could act out on these threats.

MCCROSSIN stated she did not wish to press charges at this time and was advised to contact police if there were any updates or issues. rl

Case Report by Officer Bullock

On 12/25/22 Officers responded to 1846 4th Street for the report of threats. Upon arrival, Officers made contact with the caller, PAMELA STRATFORD. STRATFORD stated that she received multiple messages, both audio and text through Facebook messenger, from her son, ZACHARY ZORAN. STATFORD stated that, ZORAN sent her threatening messages and believes that, ZORAN is possibly under the influence of Methamphetamine. STATFORD stated that she has had issues in the past with ZORAN, who is her biological son, with drug dependency issues, as well as psychological issues, possibly schizophrenia. STRATFORD stated that she used to have a civil protection order against, ZORAN, however, dropped it when he became sober. STRATFORD stated that she believes ZORAN is no longer sober and is uncontrollable. STATFORD has current custody over, ZORAN'S son that lives with STATFORD.

ZORAN messaged STATFORD through Facebook messenger, under his Facebook account, stating that he was going to kill, STRATFORD. ZORAN also sent a message stating that STRATFORD was going to die, as well as another individual unrelated to the report. STRATFORD stated that she believes that ZORAN will cause her physical harm and possibly damage her property and has unknown intentions on what, ZORAN can do. STRATFORD stated that she does not feel safe knowing that ZORAN is out there and has bad intentions to harm her and possibly kill her.

STRATFORD signed a complaint for Aggravated menacing, as well as signed a Temporary Protection order that was filed through Police Dispatch to be immediately filed. Documentation of the messages were uploaded with the case and the case report was completed. At this time, ZORAN'S location is unknown and Officers were unable to continuously make contact, with ZORAN. rl

At approximately 1730 hours, on 12/25/22, Officers received a phone message from, PAM STRATFORD the victim, in reference to a call back. Officers made contact with her by the phone, STRATFORD stated that she once again felt concern for her safety, due to seeing a Facebook post that was made by the suspect in reference to having multiple weapons. STRATFORD stated that it appeared that the suspect got in an altercation previously and broke his hand and was discharged from the hospital and STATFORD stated she was concerned from her safety with a history of weapons and mental illness and narcotic use. Officers have logged an extra patrol for, STRATFORDS house and have advised her of additional safety measures that she can take. rl

Supplement by Officer Shover

I was dispatched to the police department lobby to take a report of a violation of protection order where I sat and spoke with PAMELA STATFORD. PAMELA STATFORD advised she has a protection order against her 32 year old son, ZACHARY ZORAN. Also a protected party in his protection order is ZACHARY's son, PAMELA's grandson, GABRIEL ZORAN. In looking at the paper work it is looking like the protection order number is 2019082168. It was issued August, 2019 and it expires August of 2021. PAMELA STRATFORD is reporting that her son ZORAN had been continuing to caller her on numerous occasions throughout last week, from the middle of last week onwards, reference wanting his money.

Apparently she has money that comes in from his annuity or SSI check and he was calling because he wants it. She stated that she made contact with the nursing home that he is in, and he is in there for some medical conditions that he is suffering from and she also says he suffers from drug addiction as well as paranoia and schizophrenia. She reports that he is currently in Wyant Woods nursing home in Akron and that's where he is calling from. He is calling wanting his money and has called several times, the final time being on Saturday, 3-15-2020, demanding that he wants his money. Initially the nursing home stated that they would not accept the money and they do not have the means at the time to accept the money. PAMELA was able to make some sort of arraignment and was able to drop money off on Monday, 3-16-2020 and actually obtained a receipt so the money is all dropped off that was needed to be dropped off.

Apparently he had called previously too regarding a court date that is coming up. There is a trial or court date that she is referring to in which visitation apparently is up for discussion on who can be around ZACHARY. There was some comments about that as well where if he stated that if he doesn't get his money that "you're going to pay for that" and that if he doesn't get the visitation that "she would be sorry". She feels that these were threatening. She did not respond when I asked her why she waited at least a week from him initial contact with her to make a report. It seems that she made contact with GABRIEL's attorney and advised him of the situation and I believe that is what brought her to the police department today.

When I asked her what she wanted to do about prosecution, that it could be difficult since the conversations have been going on and she has been letting him call her now for approximately a week, she advised that she just wants him to stop. I advised that possibly our prosecutor's office could send a cease and desist letter. I then also advised her that from this point on if he's wanting things or calling for things she needs to just advise that he is not allowed to call here and then start documenting it and reporting it right away, do not wait of hesitate if he is violating any terms of the protection order to report it immediately. She agreed and understood those conditions but still was adamant that still she just wanted him to stop with the calls. She did state that since she's dropped the money off at the nursing home that she has not received a call from him since. She said that will last only until he needs something else and then the calls will start again. She was given a business card with the information for the prosecutor and perhaps they can assist in the contact of ZACHARY ZORAN at this time.

STRATFORD reports that her son, ZACHARY ZORAN, against whom she has a protection order, has been coming in contact with her over text messages and Facebook messenger. She did just want to make this informational and have it documented that he is contacting her and he's not supposed to be. He is not threatening her in any way, just messaging how he is having a hard time being homeless in Akron. MS. STRATFORD has not replied to any of his messages.

We were able to figure out how to put the messages on "silent," that way she is not notified about them and they do not bother her and they are able to be saved still on Messenger without being deleted.

MS. STRATFORD says she is going to contact the courts Monday morning to talk about other things of the restraining order, and just wanted this documented. She is unaware of exactly where ZACHARY ZORAN is in in Akron, but again no threats are being made by MR. ZORAN and we were able to resolve the issue.

He was advised that until this was lifted by the court, he was not to have further contact with his residence. He stated that he had property he wanted to come by and grab. He was also advised that he would need to contact the courts to set up a time to come by with an officer to handle that situation. A note was left with dispatch to advise oncoming shifts that ZORAN was advised not to contact his mother STRATFORD any longer and that he has not been served with the CPO. No further incident.

Addendum by Officer Swab

On 8/13/19 at approximately 0152 hours, myself, Sgt. Perella, Officer Maltby were dispatched to 1846 4th Street for the welfare check of an 8 year old boy by the name of GABRIEL ZORAN. Officers arrived, spoke with GABRIEL as well as his grandmother and grandfather, we confirmed that the welfare of GABRIEL was top priority. GABRIEL by all accounts appeared to be happy and healthy. Once Officers were on scene, his grandmother PAMELA STRATFORD stated that she had been harassed numerous times lately by her son, ZACHARY ZORAN by telephone. After Officers cleared, we received a second call a short time later, that ZORAN had arrived at the house and was beating on the front door.

Myself, Sgt. Perella, and Officer Maltby again responded to 1846 4th Street and made contact with MR. ZORAN. We advised him that his son was safe, however he could not be at the residence, he was not welcome, at which time, MR. ZORAN became irate, initially refusing to leave the driveway, however after he was convinced to leave the property, MR. ZORAN continued to escalate himself. He then began videotaping Officers on his cellphone while screaming. Sgt. Perella advised him that he was unwelcome at the house and he could not be on the property and he could not be on anyone else's property without their permission, at which time, ZORAN began walking southbound down 4th Street until out of sight. Only a few minutes later, ZORAN was observed walking northbound on 4th Street, again approaching the house, still maintaining his phone in an upright position, as if to record officers. ZORAN was screaming and yelling various things regarding Officers failing to ensure the safety of his son and stating that he could be anywhere he wanted to when he wanted to.

MR. ZORAN'S agitation continued to escalate, as he walked out into the street and began approaching Officers patrol cars, still screaming after being warned to leave the area, at which time, it was decided that ZORAN was to be placed under arrest. Sgt. Perella attempted to grab a hold of ZORAN. ZORAN began to pull away from Sgt. Perella, at which time, Officer Maltby and I attempted to also gain control of ZORAN by grabbing his arms and his legs. ZORAN continued to resist Officers and he was taken to the ground. Once on the ground, I observed Officer Maltby's leg, pinned in between, MR. ZORAN and the ground. As Officer Maltby attempted to free himself. I observed ZORAN taking both of his arms, lying in the belly down position and tucked his arms and his hands underneath his chest, refusing to release them to be handcuffed. ZORAN was advised several times to give up his arms and he continued to refuse.

Once Officer Maltby was able to free himself, I was able to gain control of ZORAN'S left arm. I brought it behind his back and applied handcuffs to his left wrist while still trying to maintain control of his left arm. Officers were then able to release his right arm from underneath him and the second handcuff was placed on his right arm. I

advised dispatch that he was in custody and after attempting to properly space and double lock the handcuffs; I conducted a pat down search through his pockets. His belongings were taken out and collected and ZORAN was escorted by Officers into the back of Sgt. Perella's patrol car. ZORAN was then transported back to the Cuyahoga Falls City Jail for processing. He was escorted downstairs into the jail area, where he continued to scream and yell, however with Officer Vanadia in the jail, he attempted to reason with ZORAN, which did seem to calm him for short periods of time. After several minutes of waiting in the jail, Sgt. Perella, Lt. Norfolk and Officer Maltby attempted to serve ZORAN with his copy of the criminal charges as well as gave him several opportunities, to sign for a PR bond so that way he would not have to stay in the jail overnight however ZORAN despite several attempts by Officers to explain the bond process. He still refused to sign the PR bond offered to him and was advised that he would have to stay in the jail until he made his court appearance. ZORAN was adamant that he would not leave the room until he was given his cell phone to make a phone call, even after Officer Vanadia offered ZORAN countless opportunities to make phone calls using the landline available to him.

ZORAN was ordered to stand up to be taken back to the jail area, where he again refused. Once Officers were able to gain control of him. He assumed a dead weight position, refusing to move and once again attempting to tuck his arms into himself. Officer Vanadia and I placed him into the escort position on both the left and the right side and we walked back into the jail cell area. Once in the jail cell area, he refused to remove contraband clothing items that he had, at which time, he was placed up against the wall and the contraband items were removed from him. ZORAN was then placed into the jail cell where he was later served with his copy of the criminal charges.

ZORAN continued to be extremely agitated with the entire process and had several instances when his mood would rise and fall through the entirety of the encounter. rl

Supplement by Officer Maltby

At 0152 I was dispatched to 1846 4th Street to check the welfare of a juvenile there. Dispatch advised that a subject identified as the father of the juvenile is calling saying that the juvenile is in danger and he has to come and get him right away. While en route at the request of the dispatcher, I did call into dispatch and was advised by dispatcher, COLLINS that the mother of the caller, who has full custody of the callers son, also called in stating that the caller, later identified as, ZACHARY ZORAN has been harassing her and will not leave her alone. She states that she does have full custody of ZORAN'S son and she believes ZORAN is having a mental episode.

Upon my arrival, I made contact with, PAMELA STRADTFORD, STATFORD indicated that she is the grandmother of, GABRIEL ZORAN and has had custody of him and he has lived with her for five years and she has officially had custody of him for four years. She stated that his father, her son, ZACHARY ZORAN is schizophrenic, regularly off his meds and also abuses drugs. She states that abuses drugs and alcohol. She states that he has been escalating recently and keeps calling her paranoid that something is going to happen or has happened to his son, GABRIEL ZORAN.

Sgt. Perella and I conducted the welfare check and GABRIEL who was awake at the time, was in very good spirit. GABRIEL also appeared healthy and well fed. In speaking further with, STRATFORD she did indicate that ZORAN has been showing up at the door and pounding on the door and demanding different things. Earlier this evening he demanded that they give him his silver coin collection, which they did willingly turn it over to him, but they did not want him in the residence. STRATFORD does fear that eventually, ZACHARY is going to become violent, as he does tend to stand outside pound on the door and yell a lot when he comes over.

After collecting all the information that we needed from STRATFORD and advising her to call us if ZACHARY does show up, we then all left the scene and I parked nearby at Dewitt Elementary. Just a few minutes after leaving the scene, I noticed a Mini Van taxi cab pull up out in front of the residence. I then drove past the residence again and saw ZORAN beating on the sliding glass door on the south side of the residence. I called out over the radio and swung back around and then pulled up the driveway, right as dispatch was advising STRATFORD had called 911 hysterical saying that ZACHARY was pounding on the glass.

I made contact with ZACHARAY who was very irate that they would not let him in and he continued to go on about how he had already called CSB and that we must sit there and wait for CSB to arrive so that he can get his son out of that residence. ZACHARY stated that he feels that people are harming GABRIEL and when asked if they were there right now. He stated no. ZORAN continued to rant on about delusions that he has had in his past as well as his childhood. Once ZORAN realized that we were not going to just let him take his son with him, he began recording us on his cellphone and ordering us to tell him our badge numbers. Sgt. Perella grabbed one of my business cards from and wrote our badge numbers down and attempted to hand it to ZORAN who refused it and then eventually did take it from us.

We ordered ZORAN not to return and advised him that he is not welcome at that residence. We also warned him multiple times, to calm down and to stop yelling as he was walking up and down the sidewalk on 4th Street filming us and loudly yelling. He then walked around the corner onto Sackett and then returned about a minute later and continued to yell and then was out in the middle of 4th Street, at which point we warned him a few more times to leave the area and ordered him to turn around and put his hands behind his back, at which point he started to rapidly move away from Sgt. Perella, as Sgt. Perella was attempting to grab a hold of his arms. He was then told that he was under arrest and continued to resist. Sgt. Perella and Officer Swab got ahold of him. I also reached to grab him as he started to fall down to the ground. As ZORAN fell, he ended up falling on my leg, tripping me causing me to fall down to the ground with him. I caught myself as I fell and landed on my left hand, resulting in swelling of my palm and they base of my thumb of my left hand.

While ZORAN was lying on my left leg, Officer Swab and Sgt. Perella were struggling to get him handcuffed and they eventually did have a good enough control and grip on him that they were able to get him up so I could slide my leg out from underneath him so I could assist in cuffing ZORAN up. Officer Vanadia arrived on scene and a short time later, Officer Moledor also arrived. Officer Vanadia helped us left ZORAN off the ground and placed him into the back of Sgt. Perella's patrol car.

I did go back and spoke to STRATFORD advising her what had happened and that he was being arrested. She asked what she needed to do to get a protection order and I provided her my business card with this report number on it and pointed out the phone number on the back regarding seeking a protection order.

I then went to the station and drew up charges for a misdemeanor of the 4th degree disorderly conduct and a second degree resisting arrest. I checked myself out and confirmed that my palm was still swollen and my left pant leg does now have a hole in it down by my ankle, but no other evident injuries.

After drawing up the charges, I took ZORAN'S copies down to booking room #1, where Officers Vanadia and Swab had been running ZORAN through the booking program. ZORAN refused to sign the bond paperwork and after multiple attempts of coaxing him to sign the paperwork and or explain to him that he would have to sit in our jail by Officer Vanadia and Sgt. Perella, we did once again have to grab ahold of ZORAN and walk him over to the jail. Officers Vanadia and Swab were the ones that walked ZORAN over to the jail and as we stepped in front of his open jail cell he was still refusing to cooperate and I had to remove both his shoes as well as his belt. After removing both shoes, I started to unbuckle his belt, however he was forcing his waist up against the concrete block wall of the jail and as I continued to struggle to unbuckle his belt he did force his waist up against the wall of the jail, crushing my left middle finger right on the knuckle and I did feel a pop in my middle finger. I then was able to yank his belt to the side unbuckle it and pull the belt out of the belt loop, resulting in the belt breaking as I attempted to remove it while he was still refusing to cooperate and struggling with us. ZORAN was then placed in the jail cell.

ZORAN was given a court date of this day, 8/8/19 at 0830 hours at Stow Municipal Court to answer to the two aforementioned charges. Officer Swab completed the use of force report and I also did fill out the job injury packet regarding my left palm, thumb and left middle finger.

ZORAN was advised that he is not to return to 1846 4^{th} Street, or else he will be charged. rl

Addendum by Sgt. Perella

Ptl MALTBY, SWAB and I had conducted and cleared 1846 4th St. on a welfare check of 8 year old GABE Zoran. GABE'S father ZACHARY Zoran was the original caller, and during the incident we learned from ZACHARY'S mother PAMERLA Stratford that ZACHARY is a diagnosed paranoid-schizophrenic and drug user who had been pestering her with texts and phone calls regarding GABE. PAMELA described ZACHARY as being in a manic state of irrational fear regarding GABE and she feared that he would come to the residence. PAMELA has had custody of GABE for the last 5 years due to ZACHARY'S mental state and drug use. PAMELA told us that the bulk of ZACHARY'S texts this evening were regarding his "memories of something happening to him" when he was a child, and of his unfounded fear that "something would happen to GABE". When we left the residence initially, PAMELA advised that ZACHARY was currently unwelcome at her residence and she was fearful that he would arrive there and cause problems. We assured her that we would respond if needed.

Moments after we'd cleared PAMELA advised Dispatch that ZACHARY was "pounding on her glass door". Ptl MALTBY arrived back to the residence 1st and was speaking to ZACHARY at the side door when I arrived shortly thereafter. When I approached, ZACHARY was making statements such as "he would not leave" until officers checked GABE'S welfare, and when he was informed that had already been accomplished, ZACHARY said he "would not leave until he went inside the residence". ZACHARY was told that he was not welcome inside the residence or on the property, and he again stated he "would not leave until CSB arrived and he went inside with them".

ZACHARY then made the statement that "when he was a child he had visions that something happened to him" and he thought something "might be happening" to GABE at the residence. ZACHARY named the persons he though were responsible in his "visions", but said none of them resided at 1846 4th St. nor were there currently (*Note: This delusional statement caused us to decide to pink slip ZACHARY after his arrest for DOC/Resisting and he was even told at one point during booking that he would be transported to the hospital. However he made no further delusional statements and it was decided to release him on a PR Bond. Unfortunately after his arrest he refused to sign his PR Bond, refused to leave the booking room and had to be escorted to his cell*)

ZACHARY was again told that GABE'S welfare had already been checked and that GABE was in no danger. It became apparent that there would be no reasoning with ZACHARY, as he began to shout that we "did not care about an 8 year old boy who was being abused" etc. and turned his cellphone camera on to film us. ZACHARY then began a loud rant and demanded our badge numbers, but when given them was not satisfied; he instead wanted them "written down", which I did for him on Ptl MALTBY'S business card, then wanted our "actual badges off of our uniforms".

ZACHARY was still loudly adamant on remaining on the property and was again told he needed to leave. He briefly walked south on 4th St. toward Sackett Ave. and disappeared around the corner on Sackett Ave. for moment then came walking back. He was told to not come back onto the property of 1846 4th St. or he would face arrest.

ZACHARY then began to walk in the middle of the roadway around our cruisers and film or take photos of the car numbers loudly proclaiming that he was getting the license plates of the squad cars. I then told ZACHARY to come here, that he was under arrest. ZACHARY answered "No" several times and quickly walked or started to run away from all 3 of us. I grabbed ZACHARY'S arm and again told him he was under arrest. ZACHARY shouted "NO" and "For what" etc. and pulled away from me and also from Ptl MALTBY and SWAB who were also attempting to control him. We ended up taking ZACHARY to the pavement in order to gain control of him and requested that he place his hands behind his back, but he continued to shout forcefully "GET OFF OF ME! I DIDN"T DO ANYTHING. GET OFF, GET OFF, GET THE FUCK OFF ME" etc. ZACHARY was on his stomach, his right arm was underneath his body and he refused to comply with requests to give control of his right arm to officers. ZACHARY kept shouting that he wanted "to put his phone in his pocket". ZACHARY writhed and squirmed around, apparently attempted to free himself, while we continued to request that he give up his right arm.

Eventually we were able to get his right arm free, or he did relinquish control of it and we did get him handcuffed. Ptl VANADIA and MOLEDOR also arrived (after ZACHARY was secured) with Dispatch sending additional units (due to my microphone keying up during the struggle). ZACHARY was placed into my cruiser, car #8 for transport to the station for charges: Disorderly Conduct M-4 and Resisting Arrest M-2. Ptl VANADIA assisted Ptl SWAB with booking. ZACHARY did suffer minor visible scrapes to his elbows which were photographed and placed on the Public Drive. As previously stated, ZACHARY refused to sign his PR Bond and was placed into a cell after his clothing had to be forcibly removed.

Made contact with ZORAN again and told him it was time to go and he complied.

Before clearing, I was advised by radio to make contact with STRATFORD again. I did and she said her arm hurt. She said he had been pushing her in her right arm. She said not punching, but just giving her little pushes. She had previously fractured that arm and now it hurt. She did not describe any means that he attempted to cause her harm. She wanted to know if any action could be taken about him hanging up her phone and I told her no, today we addressed the issue by telling him to leave and letting her know if he comes back, call us. She was satisfied with that result. drb
