### Narrative:

On Tuesday, March 25, 2025, at approximately 1130hrs, SAs Dan Boerner and Laurna McClintock examined Matrix Item 19 (Gray t-shirt, Puma, size 3XL) for items of suspected evidence<sup>1</sup>. The gray t-shirt was photographed as it was found and examined for suspected ballistic impacts. Three suspected ballistic impacts were observed on the front of the t-shirt and four suspected ballistic impacts were observed on the back of the t-shirt (Figures 1-2, Suspected ballistic impacts).
