**Narrative:**

On Monday, October 13, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) and SA Jack Shea (Shea) contacted Emergency Medical Transport, Inc. (EMT) Operations Manager (OM) Roy Poynter (Poynter) at the EMT office which is located at 1122 East Midlothian Boulevard, Youngstown, Ohio.

SA Tingley requested a copy of the EMS run report documenting the EMT response to 4312 Helena Avenue and the treatment of Ricco Acevedo (Acevedo) at that location. OM Poynter requested a letter on BCI letterhead be sent to him at which point he would release a copy of the EMS run report.

SA Tingley prepared and sent the aforementioned requested letter and OM Poynter acknowledged receipt and sent SA Tingley a copy of the EMT Run report via email.
