Investigative Request:

On Monday, November 17, 2025, Lt. Scott Blankenship of the Union Township Police Department (Clermont County) requested the assistance of the Ohio Bureau of Criminal Investigation (BCI), to conduct an independent investigation into the facts and circumstances surrounding an officer-involved critical incident. The incident occurred on November 17, 2025 near 4272 Cider Mill Drive, Cincinnati, OH 45245 and resulted in the death of Thomas Noble.

Preface:

This report serves as a synopsis of the investigation into the November 17, 2025 officer-involved critical incident in Clermont County, Ohio. This report only summarizes the information that the author determined to be the most useful in achieving an overall understanding of what occurred in this incident. Not all facts and details are presented in this summary report. Therefore, it is recommended that each individual report from which this document is derived be read to obtain a complete understanding of this investigation. Further, audio and/or video recordings exist for most of the interviews conducted, revealing further details of statements given regarding the incident.

This investigation was conducted with the purpose of determining, to the extent possible, the facts and circumstances surrounding this incident. As unbiased collectors of fact, the investigative team has not and will not render any opinion of the legality of officers' actions. Instead, it is anticipated that this investigation will provide the basis of information for decisions to be rendered by the appropriate authorities.

Investigative Team:

BCI Special Agent Lauren Frazier (SA Frazier) was assigned as the lead case agent. SA Frazier received assistance in the investigation from SA Sean Zint (SA Zint) and SA Brady Curry (SA Curry). BCI Crime Scene Technician Holly Ryczek of the Crime Scene Unit processed the scene of the incident, by documenting, preserving, and collecting possible evidence. The investigation was supervised by Special Agent Supervisors William Jones and Kevin Barbeau.

Additionally, various personnel from the BCI crime laboratory performed scientific analyses on submitted items of potential physical evidence.

Summary of Investigative Process:

The following is a partial list of investigative activities or methods which were employed during this investigation, to thoroughly and accurately locate and document all pertinent facts and circumstances regarding this incident:

- Recorded interviews of the two officers who discharged their weapons
- Recorded interviews of four officers who were involved in the incident, at the scene, or otherwise deemed to potentially have relevant information
- Neighborhood canvass of the area surrounding the incident, completed by members of the Union Township Police Department
- Interviews of first responders and medical personnel
- Interview with mother of the decedent
- Special agent attendance at post-mortem examination (autopsy) of the deceased
- Obtained and reviewed the preliminary autopsy report and autopsy photographs
- Requested the post-mortem examination report, toxicology report, and death certificate, which will be received on a later date
- Obtained & reviewed police reports of prior law enforcement contacts with the subject
- Obtained and reviewed open and closed-source biographical information on the involved subject, including criminal history reports, OHLEG, driving records, etc.
- Review of all available body worn cameras involved in the incident
- Review of all available surveillance videos which captured the incident
- Processing of the scene for potential evidence (photographing, searching, measuring, documenting, and collecting)
- 3D scans/model of incident area
- Reviewed radio communications utilized during the incident
- Review of 911/phone communications related to the incident
- Review of dispatch/CAD records pertaining to the incident
- Review of the department's reports, photographs, and investigative materials pertaining to the incident, excluding any Garrity statements or information derived from any compelled statement
- Received forensic laboratory examinations to include:
 1. Firearm identification testing of involved firearms, casings, and bullets
 2. Firearm operability testing
- Collected and reviewed the departmental personnel files of the officers involved in the shooting, to include training and disciplinary records (if any)

Incident Summary/Overview:

On Monday, November 17, 2025, at approximately 2042 hours, officers with the Union Township Police Department (UTPD) were dispatched to 4272 Cider Mill Drive, Cincinnati, Ohio 45245 for a reported 911 hang-up call. The 96-year-old mother of the involved male subject, later identified as Thomas Noble (Noble), stated that her son was having personal issues and was holding her hostage. When officers arrived on scene, they attempted to speak with Noble through negotiation attempts, asking him to release his mother.

During the negotiations, Noble was reported to have presented a handgun while exiting the residence. Two officers fired their weapons and Noble was struck. UTPD officers began rendering aid before Noble was transported by medics to Mercy Anderson Hospital. Noble succumbed to his injuries and was pronounced deceased at 2213 hours by Dr. Patchell. No officers were injured during the incident. BCI Crime Scene Unit processed the scene and recovered a BB pellet gun that was a replica of a semi-automatic firearm.

Decedent:

Thomas Noble was a 37-year-old male living at 4272 Cider Mill Drive, Cincinnati, OH 45245 with his 96-year-old adoptive mother, Marilyn Noble.

Over the past 25 years, Thomas Noble had approximately 45 interactions with the Union Township Police Department, to include: Theft, Criminal Damaging/Vandalism, Runaway/Missing Person, Receiving Stolen Property, Criminal Trespass, Possessing Criminal Tools, Forgery, warrants, Obstructing Official Business, Burglary, traffic related offenses, domestic disputes, welfare checks, and a drug offense/overdose.

In the months prior to this incident, the Union Township Police Department was dispatched to numerous incidents involving Noble. These incidents are summarized below:

- 06-05-2025 - UTPD Incident Report# 25-8537 - Officers responded for a welfare check. A social worker called police due to Noble making comments about self-harm. Officers responded and advised the male was not suicidal.
- 07-31-2025 - UTPD Incident Report# 25-11664 - Officers responded to an overdose. Medical care was refused.



- 11-16-2025 - UTPD Incident Report# 25-017889 - Officers responded to a complaint by Thomas Noble that his girlfriend, Ashleigh Remley, took his phone and possibly his medication. Noble located his phone and officers cleared the scene.

Autopsy Report

The post-mortem examination (autopsy) of Thomas Noble was performed on November 18, 2025, at the Hamilton County Coroner's Office. The autopsy was conducted by Forensic Pathologist Jennifer Schott, M.D. Preliminary findings show that the cause of death was

The final autopsy report, toxicology report, and death certificate were requested and will be received on a later date.

Physical Evidence

The BCI Crime Scene Unit was requested to respond to the scene, to document and preserve any items of potential evidence. The scene was processed, to include photographing and mapping the area, as well as the search for, documentation of, and collection of items of evidence. Detailed crime scene reports were completed, with the below information only summarizing some of the more significant findings.

Scene 1 (4272 Cider Mill Drive):

The scene had been cordoned off by UTPD with yellow crime tape, multiple law enforcement vehicles, and uniformed personnel. Suspected blood was located to the north of the residence, which was where Noble had reportedly been shot. Cartridge cases were located to the south of the residence, which was where officers had been standing.



The scene was observed to begin on the driveway of 4270 Cider Mill Drive and end in the driveway of 4274 Cider Mill Drive. A total of six (6) Hornady 5.56 NATO cartridge casings were located and collected (Items #1, 7, 8, 9, 10, & 12). Three (3) cartridge cases were collected near a white Volkswagen Tiguan (OH-JJR3467) in the driveway of 4270 Cider Mill Drive. The other three (3) cartridge casings were located to the north of the Tiguan in the front yard grass.

Across the street, between 4271 Cider Mill Drive and 4273 Cider Mill Drive, a blue Saturn Ion (OH-KLG4173) was parked. A WIN 9mm Luger cartridge case was observed on top of the front driver windshield wiper (Item #2). An area of suspected blood was located at the beginning of the driveway at 4274 Cider Mill Drive. Swabs of this suspected blood were collected as Item #3.

All firearms had been collected by UTPD personnel prior to BCI arrival. The weapon Noble reportedly had was in Union Township Cruiser #05219. Two firearms were in the front passenger side of the vehicle. A black Sig Sauer rifle was collected as Item #4 and later determined to belong to a non-involved officer. A second weapon was located on the front passenger floorboard. This weapon was a black Ruger P345PR 6mm CO2 Airsoft BB gun (S/N: 21M014661) with no CO2 cartridges and no BB pellets in the chamber (Item #5).

Item #5 - Black Ruger BB gun

An involved law enforcement pistol was in UTPD Detective Cooper's unmarked vehicle, later determined to belong to [REDACTED]. The firearm was a black Smith and Wesson M&P M2.0 9mm Luger pistol (S/N: [REDACTED]) containing one 9mm Luger cartridge in the chamber and a seated magazine containing 15 9mm Luger cartridges. The firearm had a TLR-1 HL Streamlight attached to the frame and a red dot optic attached to the slide. The firearm, magazine, and cartridges were collected as Item #6.



Item #6 - [REDACTED] handgun

Numerous suspected ballistic impacts (BI) were observed in the area surrounding the incident. Additionally, evidence items were collected from the hospital and autopsy.

Union Township Police Department:

[REDACTED] patrol rifle was in the trunk of UTPD cruiser # [REDACTED]. The rifle was removed by UTPD Lt. Blankenship before being photographed. SA Frazier documented and photographed [REDACTED] rifle, a Smith and Wesson, M&P 15, AR-15 rifle with serial number [REDACTED]. The rifle had a Sig Sauer Romeo 5 red dot sight and a Baldr Pro tactical light. UTPD Lt. Blankenship removed the seated magazine and ejected one (1) cartridge from the chamber.

The seated magazine contained 23 cartridges. An additional magazine was affixed to the seated magazine. The additional magazine contained 30 cartridges.



Item #11 - [REDACTED] rifle

BCI Laboratory Analysis:

Various items of potential evidence were submitted to the BCI Laboratory for analysis. The actual reports should be consulted as the following synopsis does not include many of the details from the full reports.

The BCI Firearms Section was requested to perform an analysis of the officers' firearms, as well as the firearm-related evidence collected from the scene (casings and bullets). By comparing evidentiary cartridge casings/projectiles to known standards from each weapon, identifications can be made as to which casings/projectiles were fired from each firearm. Of the casings/projectiles recovered, the following identifications were made:

Findings:

- Smith & Wesson pistol (S/N [REDACTED]) - operable
 - One (1) fired 9mm Luger cartridge case - source identification
- Smith & Wesson rifle (S/N [REDACTED]) - operable
 - Six (6) fired 5.56mm NATO cartridge cases - source identification
- Two (2) fired bullet jacket fragments:
 - Smith & Wesson pistol (S/N [REDACTED]) - source exclusion
 - Smith & Wesson rifle (S/N [REDACTED]) - inconclusive
- Two (2) lead fragments - unsuitable

Witnesses:

David Feld, a neighbor residing at 4273 Cider Mill Drive, was identified as a witness to a portion of the officer involved critical incident. Feld stated that he has known Thomas Noble since he was a kid. A few days before the incident, Noble texted Feld wanting to talk. Feld was out of town and Noble never contacted Feld. On the date of the incident, Feld said he observed police outside his home. Feld watched the police activity out his 2nd story window, which faces

Noble's residence. Feld observed Noble running very fast out of his house and shortly after, heard gunshots from police. Feld stated he saw Noble fall to the ground. Feld stated he did not see anything in Noble's hands and did not know why Noble ran out of the house. A photograph was taken, documenting Feld's point of view (see below).

Officer Interviews:

The following interview is the officer's account of his actions pertaining to this incident. A more detailed account can be found by reading the separate report written and by reviewing the audio recording of the interview.

Interview:

On the date of the incident, ██████████ stated that he was at the police department, typing up charges for an unrelated incident. He heard via radio officers got dispatched to an incident involving a code 40, which is a firearm. He heard that the subject's mother and girlfriend were at the residence and it was starting to become a hostage or suicide by cop situation.

[REDACTED] put himself in route to the call through his in-car computer and radio. He said that he initiated his lights and siren and responded to Cider Mill Drive. [REDACTED] said that he turned off his overhead lights and siren a few hundred feet before he arrived so that the subject didn't know officers were approaching. He said that [REDACTED] was in front of him and [REDACTED] arrived behind him.

He met with other officers already on scene, to include [REDACTED]. He said that [REDACTED] was on the other side of the street with his cruiser. [REDACTED] gave officers a description of the

correct house, stating that there was a basketball hoop. [REDACTED] said that officers began toward the involved residence, 4272 Cider Mill Drive.

[REDACTED] used a printed diagram of the scene to reference during this interview. While referring to the diagram, [REDACTED] described that [REDACTED] was in the driveway of 4270 Cider Mill Drive, positioned behind a vehicle. [REDACTED] was with him but then he moved to another vehicle with a better view of the front door. [REDACTED] said he was positioned behind a vehicle parked on the street near the front of the subject's residence. [REDACTED] was behind a vehicle in the driveway of 4273 Cider Mill Drive. [REDACTED] was near his cruiser, which was parked on the street just north of the subject's residence. [REDACTED] said that cars were driving through the street, so [REDACTED] had [REDACTED] move his cruiser to block off the roadway.

[REDACTED] said that officers were waiting outside and getting updates from dispatch, stating that the subject was making threats about harming himself and stating that officers were going to have to kill him. [REDACTED] had dispatch transfer the male caller to a 19A, which was his cell phone. [REDACTED] said he could hear [REDACTED] talking to the subject. He recalled [REDACTED] telling the subject that officers did not want to hurt him. [REDACTED] said that it didn't sound like the de-escalation was going well. He stated that the subject was locked in on wanting to harm officers or have officers harm him. He stated that Sgt. Shaw arrived on scene and got in position near [REDACTED].

[REDACTED] said that he did not have the best line of sight, describing that he could see the garage but couldn't see the front door. He said that he could see down the right-side alley, side door, and backyard, in case anyone exited from the rear or side of the residence. He said that [REDACTED] was still on the phone with the subject and told officers to get ready because he was going to release a female. [REDACTED] told [REDACTED] that if the female came out of the residence, that he was going to give her commands and secure her.

[REDACTED] said that he could not see the front door but was told by other officers that the front door opened. He was told a female was at the door but not coming out of the residence. He recalled a canine coming outside and barking at officers. Other officers stated that the female was going back inside. Then, a male appeared and [REDACTED] or [REDACTED] stated that the subject had a gun. [REDACTED] said that [REDACTED] then aired via radio that the male was pointing the weapon at him.

[REDACTED] said that he took a kneeling position on his left knee and used the rear vehicle bumper as cover. He heard [REDACTED] still on the phone with the subject, telling him not to come out of the house with a weapon. A short time later, [REDACTED] stated, "here he comes." [REDACTED] stated that the subject ran out of the house with a weapon, described as a handgun, pointed upwards while he was running. [REDACTED] noted that the subject was

running weird, which he described as skipping high in the air while running diagonally through the yard toward the neighbor's sidewalk.

He said that he heard [REDACTED] fire approximately 2 to 3 rounds. [REDACTED] said that he was still trying to get a good shot, while considering his backdrop and surrounding area. He said that [REDACTED]'s rounds did not affect the male, so he stood up and fired one round toward the subject's midsection. He said that the subject was approximately 20-25 feet away when he fired and was just coming out of the yard and onto the sidewalk. He was unsure if his round hit the subject or not. [REDACTED] heard [REDACTED] fire another 2 to 3 rounds a few seconds after. At that point, he observed the male subject fall onto the sidewalk.

[REDACTED] said that the subject was running directly toward the location of [REDACTED] and [REDACTED]. He said that he didn't think that the subject knew there were other officers nearby. [REDACTED] believed that [REDACTED] was the subject's main target because his cruiser had the spotlight pointed at the house. [REDACTED] was asked if he believed the subject was going to shoot at officers and he stated yes, he believed that the subject was going to seriously harm or shoot an officer. [REDACTED] stated that he was in fear for the lives of other officers and that's why he fired his weapon. He said that he stopped firing because his backdrop changed and it was not safe for him to fire.

Another officer radioed that shots had been fired. [REDACTED] said that he started running toward the subject then realized that officers still needed to clear the house. He observed [REDACTED] already at the front door and joined him. He said that [REDACTED] kicked the door in, using a donkey style kick and switched to his handgun.

Officers believed that there were two females inside the residence. [REDACTED] said that an older female was lying in a hospital type bed in the living room. [REDACTED] was telling her to show her hands but said that she seemed confused and disoriented. [REDACTED] stayed with the female, while [REDACTED] and Sgt. Shaw cleared the residence. The elderly female told officers that no one else was inside.

[REDACTED] spoke to the female who told him that her son was severely intoxicated and that officers had talked to him the night prior. She told him that her son was acting crazy and had a weapon. The female said that she called 911 and tried to go into her room down the hallway. She told [REDACTED] that her son grabbed the phone and she tried to hide in the garage. Officers had a medic respond to check on the female. She had [REDACTED] and was ultimately transported to Mercy Anderson Hospital.

[REDACTED] was asked if he knew the subject or had any prior contact with him and he stated no. [REDACTED] stated that he did not give any verbal commands prior to firing his weapon. After the subject was shot, [REDACTED] said that he heard a scraping noise on the ground

from someone kicking the gun presumably away from the subject. When asked if the subject fired his weapon, [REDACTED] stated that he did not believe so. At the time of the shooting, [REDACTED] was asked if he perceived any other options other than the use of deadly force and he stated no.

While on scene, he said that Detective Wilford took possession of his handgun. [REDACTED] said that he did not manipulate the firearm and the gun remained on scene until collected by BCI.

[REDACTED] Interview:

On November 17, 2025, [REDACTED] stated that he was near Old State Route 74, when he heard a radio dispatch for a 911 hang-up. As he was responding, he stated that more information was received, advising that a female called and said that a male subject, Tommy, was going crazy and there was a gun involved. He said that he was told that the male subject would not let the female go and there was possibly a second female inside.

[REDACTED] stated that he arrived on scene within a few minutes. He said that he turned off his overhead lights prior to arriving and parked on Cider Mill Drive. [REDACTED] said that he removed his rifle from the trunk, charged a round in the chamber, and contacted [REDACTED] via radio, who was already on scene. [REDACTED] said that he was trying to determine which house belonged to the subject and [REDACTED] gave descriptors over the radio to make sure officers were at the correct residence.

[REDACTED] said that [REDACTED] and two additional officers arrived right behind him. Officers continued communicating about the correct house to verify they were at 4272 Cider Mill Drive. Officers began towards the residence to try and get a better visual of the front. At that point, [REDACTED] said that he decided to move over to the driveway at 4270 Cider Mill Drive. He said that there were a car and an SUV in the driveway. [REDACTED] said he took a position behind the engine block on the SUV.

Officers began setting up a perimeter around the house. [REDACTED] said that [REDACTED] was the closest to him, on his left side. He said that [REDACTED] was in the driveway, behind a vehicle, at 4273 Cider Mill Drive which was directly across from the subject's residence. He said that Sgt. Shaw arrived a short time later. [REDACTED] was asked to block the road to the north. He was not sure about [REDACTED]'s exact location but said he was close enough that he could talk to him.

While on scene, [REDACTED] said that he could hear [REDACTED] ask to transfer the 911 call to his cell phone. He heard [REDACTED] on the phone speaking with the subject, Tommy. [REDACTED] recalled several statements made by [REDACTED] telling the subject not to come

Soon after, a female came out, let a dog out, then went back inside. At this time, [REDACTED] said that he heard [REDACTED] stating that the male subject was outside and that he had a gun and was pointing the gun at [REDACTED]. [REDACTED] said that he moved to the rear of the SUV to get a better line of sight on the front of the residence.

[REDACTED] used a printed diagram of the scene to reference during this interview. While referring to the diagram, [REDACTED] said that there was a vehicle in the subject's driveway. He described that there was an opening between the vehicle and the house. [REDACTED] further described that the garage extended west of the house, in an 'L' shape, therefore, he could not see the front door from his position.

[REDACTED] heard [REDACTED] tell Tommy to stay in the house. Then, [REDACTED] observed Tommy running through the front yard. He said he could see the subject in the opening between the car in the driveway and the house. [REDACTED] said that Tommy had his arm extended down and was running in the direction of [REDACTED]. [REDACTED] said that he was in a standing position when he fired three rounds at the subject. He saw the subject continue to run and advance towards [REDACTED]. [REDACTED] said that he took a couple steps to the west onto the sidewalk, obtained a line of sight of the subject on the sidewalk, and fired three additional rounds. After [REDACTED] had fired, he observed the subject go down to the ground.

When [REDACTED] fired, he said that he was aiming for center mass of the subject. He was asked why he stopped firing and [REDACTED] stated that the subject was no longer an active threat and no longer advancing towards [REDACTED]. [REDACTED] stated that he has viewed his body-worn camera (BWC), which helped him recall how many shots were fired and where he was when he fired.

[REDACTED] was asked if he heard any other officer's fire. He said that he heard a pistol go off between the three round volleys but did not know if the subject or an officer had fired. [REDACTED] said that he couldn't physically see the subject with a gun. He said that based on the information he was given by other officers, he believed that the subject was pointing a gun at officers. [REDACTED] said he believed that the subject was going to shoot at [REDACTED]. [REDACTED] said that he was not in fear for his life, but he was in fear for [REDACTED]'s life.

[REDACTED] proceeded down the sidewalk and observed other officers going towards the subject. He said there was enough cover there and that the house was a priority and still needed to be cleared. [REDACTED] went to the front door of the residence and [REDACTED]

joined him. He said that the front door was locked so he kicked the door down and switched to his handgun.

Inside the residence, [REDACTED] saw a female on a hospital type bed directly in front of him in the living room area. [REDACTED] gave the female commands to show her hands. He said that she was lying there and was possibly in shock. Sgt. Shaw responded with a shield and they cleared the residence, while [REDACTED] remained with the female.

[REDACTED] said that his rifle was given to [REDACTED] while on scene. He said that his rifle was not manipulated and was given to [REDACTED] loaded with one round still in the chamber. When asked, [REDACTED] said that he did not issue any verbal commands prior to firing his weapon. During the incident, he said that he heard the subject yelling but did not know what he was saying. - Tommy stated that he was holding her hostage and that he would be letting her out as soon as police get there. Tommy said that he was in the basement and was heard making statements about ending his life.
- The dispatcher asked Marilyn if Tommy had been drinking or doing drugs and Marilyn stated that his eyes looked like it and that this was his second day.
- There was some type of commotion, Marilyn is heard yelling, then Tommy gets on the phone. Tommy said that he was trying to get his mom to leave and get out of the house.
- Tommy said that he was going out to the garage and that he didn't have a gun. He said that he "has weapons but he's not shooting nobody." Tommy said, "I have one gun. She knocked out of the way from me. I'm looking for it right now. Never mind."
- Tommy is heard telling Marilyn that she has to go outside and asked what door she should come out. Tommy stated, **"I am in a spot right now where you cannot shoot me. You are not shooting me. I'm telling you right now, you come in this house, I will fucking shoot you. I'm not going to shoot my mother. I'm not going to shoot my fucking kids. I don't have kids. I'm not shooting my dog. I'm not shooting my cat. I'm not shooting nobody."**
- Tommy said that he opened the door to let his mom out. He said that Marilyn shut the door and would not leave the house. Marilyn can be heard saying that she's putting something on because it's cold outside.
- Tommy said that he put all of him mom's medication in the garbage can. Marilyn asked why and Tommy stated, "why mom, because you're my mother and I'm not right." Tommy said he's putting the medication on the porch so that the cops have them.
- Tommy said that he could see one cop and that he could hear a helicopter. Tommy stated, **"go fuck yourself, I'm going in and getting my gun."** Tommy is heard telling his mom to go out the back door then asked the dispatcher if she was outside.
- Tommy stated, **"Shoot. Just fucking shoot me dude."** The dispatcher stated that no one wanted to hurt him. Tommy said that Marilyn was in the garage and said that it was the worst place she could be. Marilyn can be heard asking Tommy to open the garage door. Tommy said that he fucked it up and that this all started over a girlfriend boyfriend thing. Tommy stated, "The dog is here. The cat is here. My mom is safe. If you think I'm going to hurt my mom, fuck you. You come in this house, let me tell you something right now."

Fucking deal with me...."** Tommy continued to tell the dispatcher to just shoot him.

- The dispatcher asked Tommy where he was at. Tommy stated that police were all around the house and "**I got guns, just shoot me. Fucking shoot me.**"
- Tommy asked if a hostage team was outside. Tommy asked who was coming because he said that they (presumably police) know he's an alcoholic and does dumb shit.
- Tommy said that he wanted to get his mom out of the house and said his girlfriend was in the house too. Tommy asked the dispatcher, "what are you doing, are you going to shoot me?" The dispatcher said no one was going to shoot him. Tommy replied, "**Oh you're going to shoot me. I hope to God you fucking shoot me right now.**"
- Tommy said that he wanted to talk to his girlfriend and then said that nobody was going anywhere. The dispatcher told Tommy that he was going to transfer the call to a Union Township Police [REDACTED].



- 21:19 hours – Sgt. Shaw spoke with a neighbor, who stated that he knows Marilyn and Tom. He said Marilyn called the police before, because Tom had a psychotic episode. He said an hour ago, that the outside light was flickering on and off. The neighbor said that Tom and his girlfriend, Ashleigh, have been having problems.
- 21:31 hours – Officers conducted a secondary search of the residence.

Conclusion:

All known people who have relevant information regarding this investigation have been interviewed, and all known records have been obtained and reviewed. BCI has striven to conduct a thorough and impartial investigation into this OICI. BCI will continue to offer investigative assistance to any newly identified witnesses or information related to this criminal investigation. It appears that BCI's investigation into this OICI is concluded, unless such new information or witnesses are identified through the grand jury or other processes. As always, we remain available for consultation and look forward to your assessment of this investigation and your decision as to any additional efforts, processes, or further assistance or involvement you might determine to be necessary.

The preceding information comprises only a portion of facts and circumstances collected during the investigation of the officer-involved critical incident. For further review of specific information or documentation collected during the investigation, please refer to the individual reports and documents from which this summary was derived.

Upon completion of this case review, it is recommended that the lead BCI Special Agent be notified prior to any press releases or completion of the case, so that the necessary notifications may be made.
