DEAR SIR:—This is to acknowledge the receipt of a communication from the chief of the bureau of inland lakes and parks of the division of conservation in your department requesting my approval of a certain reservoir land lease in triplicate, executed by the conservation commissioner to one J. O. Morgan of Columbus, Ohio.

By the lease under consideration there is leased and demised to the lessee above named the right to use and occupy for cottage site and docklanding purposes the inner slope and water front and the outer slope and barrow pits adjacent thereto that are included in the north half of lot No. 85 west of the waste gates at Buckeye Lake.

DEAR SIR:—There has been recently submitted to me for my examination and approval a certain reservoir land lease in triplicate, executed by the conservation commissioner to one Clifford C. Strader of Dayton, Ohio, leasing and demising to him the right to use and occupy for cottage site and docklanding purposes that portion of the inner slope and water front and all of the outer slope of the westerly embankment of Lake St. Marys and the State land in the rear thereof, extending back to the State ditch that is included in the south half of embankment Lot No. 62, lying south of the center line of section 12, town 6 south, range 2 east.

This reservoir land lease is one for a term of fifteen years and the same provides for an annual rental of twelve dollars (\$12.00), payable in semi-annual installments of six dollars (\$6.00) each.
