Narrative:

On Monday, November 18, 2024, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Jackson Township Police Department (JTPD) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved shooting which occurred at the Rodeway Inn located at 6880 Sunset Strip Avenue NW, Room #220, North Canton, Ohio, 44720.

On November 18, 2024, at approximately 1600 hours, Special Agent (SA) Allison Fletcher (Fletcher) arrived at Aultman Hospital and met with 8 of the involved officers from the Canton Regional SWAT Team. It was learned one of the involved officers had left the hospital prior to the agent's arrival.

The eight remaining involved officers were located in the back wing of the emergency room department. Each officer was identified with their name, their badge number, and their respective police agency. Additionally, seven of the officers were photographed in the uniform they were wearing. All photographs have been attached to this report.

It was learned that all the involved officers left the firearm used during the incident at the scene with Canton Police Department Captain Lester Marino.

On November 19, 2024, ten photographs of [REDACTED] were provided to SA Bynum from Stark County Sheriff's Office Lieutenant Donald Burns. [REDACTED] was photographed on scene after the shooting incident prior to BCI agents arriving. The photographs have been attached to this report.
