Narrative:

On March 25, 2022, BCI Special Agent Todd Fortner (SA Fortner) reviewed audio recording and dispatch records as part of the investigation into the Officer Involved Critical Incident that occurred on I–71 near mile marker 123 on March 11, 2022. SA Fortner received and reviewed audio of 911 calls and dispatch entries from the Franklin County Sheriff's Office (FCSO) and the Columbus Division of Police (CPD). SA Fortner also reviewed radio traffic audio from CPD. All the audio and the entries were recorded on March 11, 2022. A copy of the recordings and entries were saved electronically within the case file. Please refer to the files for specific quotes. The following is a summation of the information.

At approximately 0933 hours on March 11, 2022, FCSO dispatchers received 911 calls stating that a silver or gold sedan had forced a car off the road on I–70 eastbound near mile marker 87 on the west side of Columbus. Another caller advised he followed the suspect vehicle, which continued eastbound, and an occupant of the vehicle fired gunshots at him through the rear window of the car. Dispatch entries list a license plate number HKR2405.

At approximately 0957 hours, CPD dispatch began receiving 911 calls that a subject was standing on I–71 in the area of Gemini Place, shooting at southbound cars. Callers also said there appeared to be a car in the median and another subject standing near it. CPD units were dispatched and given the description of a male black, about 5'7" and skinny, with dreadlocks, wearing a red and black hoodie and black pants. 911 callers described the gun as a black and gray handgun. CPD dispatch also received reports of southbound vehicles that were struck by the gunfire. CPD dispatch was also in contact with Delaware County Sheriff's Office and Ohio State Highway Patrol to assist. A CPD unit monitoring traffic cameras located the subject and relayed his location to responding units.

At 1004 hours, the first CPD units made contact with the subject and said he was not following orders, walking northbound in the northbound lanes. At 1006 hours, a unit advised the subject was running northbound then stated, "He's firing shots, shots fired, he's fired shots." It was then aired that the subject was still running northbound, then stopped and he still had the gun in his hand. Approximately 30 to 40 seconds later, a unit requested a medic to the scene. A unit then stated all officers were okay and it was an officer involved shooting. The remainder of

the radio traffic dealt with obtaining medical aid for the subject, rerouting traffic and securing the scene.

Disposition Comments:

GOG: CALL TAKER:

1. Determine if anyone was able to get a description of hit-skip vehicle make/model, color, and license plate number.

2. If there are any witnesses advise the caller to have them stand by.

- 3. If the accident is blocking then upgrade to priority 2.
- 4. If possible, get the direction of travel of the hit-skip vehicle.

5. If the victim calls and is no longer on the scene refer to Accident Investigation (525-6113), Monday - Friday 8:00am to 4pm.

DISPATCHER:

1. If the hit-skip just occurred, air this information for all cars in the area and air 7/7A information if known

2. If the accident is blocking send an additional officer for C-62 (traffic detail).

- 3. Give the time of the accident and all other information as well.
- 4. If unable to dispatch within 15 minutes then advise the Communications Supervisor.

DETAIL CALL SHEET

EXAMPLE:

1. A blue vehicle strikes a stopped vehicle and then leave the scene.

2. A white compact 2 door vehicle strikes a wooden fence on private property and leaves the scene.
