Narrative:

On August 20, 2024 at 1211 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Allison Fletcher (Fletcher) arrived at the Summit County Medical Examiner's Office and met with Doctor Lisa Kohler (Kohler).

Doctor Kohler provided SA Fletcher with one large red biohazard bag containing 18 individually packaged items of evidence and a blue USB drive containing photos from the autopsy. A receipt was completed for the evidence transfer. Doctor Kohler also provided a copy of the evidence receipt for her office. Both items have been attached to this report.

SA Fletcher transported the evidence items to BCI, located at 4055 Highlander Parkway, Richfield, Ohio 44286. The items in the red biohazard bag were placed into temporary evidence locker #40. The photos from the USB drive were added to the case file.
