**Narrative:**

On November 19, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk (Harasimchuk) completed a review of the Mansfield Police Department's body-worn camera (BWC) video files and dash camera video files in relation to the officer-involved critical incident that occurred on October 19, 2024, at 200 Cline Avenue, Mansfield, Ohio 44907.

SA Harasimchuk located seven BWC video files and nine dash camera video files on the SIU shared drive in Reference Item A for this case file. The files were labeled as follows:

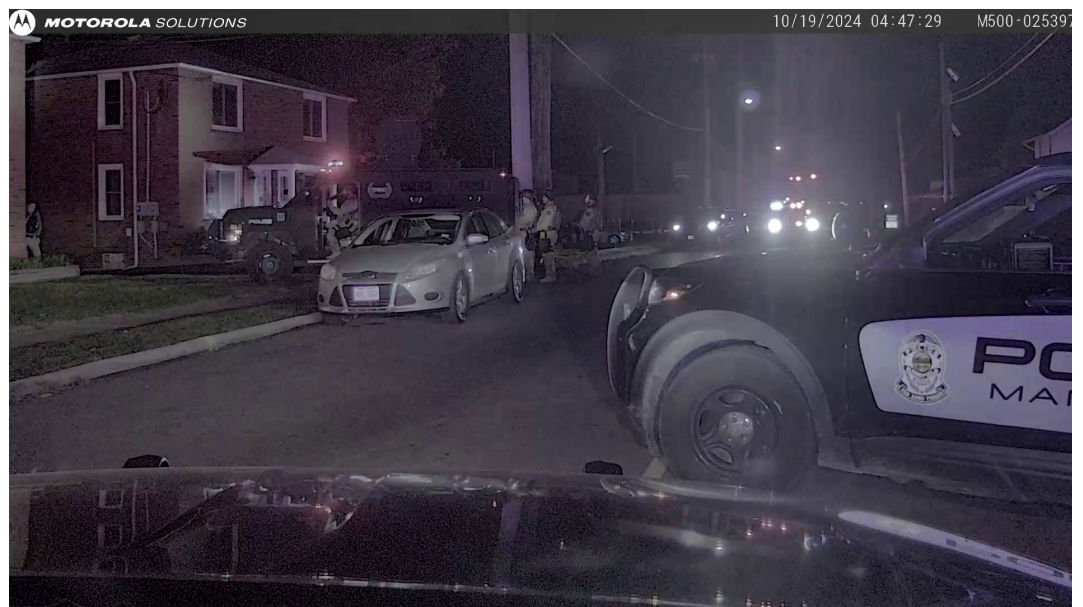
