Narrative:

On Thursday, November 07, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (SA Momchilov) compiled background information on Michael Oswalt (Oswalt), a subject involved in the incident on October 19, 2024. The information included researching past police reports involving the subject and searching criminal history records.

SA Momchilov reviewed the information and noted the following:

Overview:

In 2013, Oswalt pled guilty to the theft of multiple firearms and was sentenced to probation.

In 2015, Oswalt was charged with burglary and theft from a person in a protected class. Oswalt pled guilty and was sentenced to probation.

In 2015, Oswalt was charged with felonious assault and two counts of aggravated burglary. Oswalt pled guilty and was sentenced to prison.

In 2024, Oswalt was charged with assault on a peace officer. Oswalt was out on bond at the time of this incident.

Officers were dispatched to 26 E. Durbin Avenue in reference to a possible suicide attempt. The complainant, Oswalt's stepfather, advised that he confronted Oswalt about Oswalt stealing guns from him. Oswalt allegedly admitted to stealing the guns and pawning them (See below Summary-Report Number: 13-203-003). Oswalt's stepfather left the residence and when he returned Oswalt was found on the ground. It was reported that Oswalt may have taken aspirin, and Ibuprofen. Oswalt was transported to the hospital and later involuntarily committed (pink slipped) by a physician.

Officers were dispatched to 23 East Durbin in reference to a stolen property complaint. The complainant, Oswalt's mother, advised that some items were missing and that Oswalt admitted to stealing the items and selling them to a pawn shop.

Oswalt was later interviewed by officers. Oswalt admitted to taking firearms and other items from his mother and stepfather's residence. Oswalt further stated he took the items to pay for heroin. Oswalt was later arrested and transported to the Richland County Jail.

Oswalt was later charged and plead guilty related to this incident. Court records indicate he was sentenced to probation.

SA Momchilov requested a copy of this report through the Richland County Sheriff's Office.

Oswalt is not listed in this report and the report appears to be incomplete. However, based on court records it appears that Michael Oswalt pled guilty to this incident and was sentenced to prison.

The report indicates that Jeremiah Oswalt stated that an unknown individual broke out a small window on a second story of his business (Advanced Key and Lock Shop) and made entry. The report states the individual then stole \$100.00 in cash. Jeremiah stated he believes his cousin (Michael Oswalt) may be responsible due to "having a drug addiction."

Mansfield Police

July 4, 2015-Report Number: 15-017942

Officers were dispatched to 224 Saxton Avenue in reference to a suspicious person complaint. The suspicious person was possibly attempting to break into a residence located at 208 Saxton Drive. When the complainant confronted the individual, the individual stated he was looking for "Jason." The suspicious person was described as a white male wearing a green shirt with no sleeves.

Officers located the individual, later identified as Oswalt, carrying a laptop, box and an electronic tablet. Oswalt was asked where he was coming from, and he responded "Jason's" and that Jason had left the items on the front porch for him. Officers attempted to place Oswalt in the back of the cruiser at which point Oswalt ran from officers. Officers were able to capture Oswalt at which point he stated that, "He shouldn't have broke into the house" and that he was

"homeless and hungry." Oswalt was arrested and transported to the Richland County Jail.

Officers later returned to 208 Saxton Drive and discovered that the rear door of the residence had a window broken out.

Oswalt was listed as a driver in a motor vehicle accident. Oswalt was not at fault.

Columbus Police

Officers were dispatched to the area of I-70 West and I-71 south in reference to a multiple vehicle accident. Upon arrival, officers located Oswalt. Oswalt's behavior was described as "extremely evasive and erratic." Oswalt climbed on top of a freeway divider wall and began to throw items (small wrenches, sockets and lug nuts) from his truck, at officers. According to the report, one object, thrown by Oswalt deflected off of a vehicle and struck an officer, causing a laceration above his right eye.

Oswalt was eventually apprehended after a SWAT standoff that lasted approximately 4 hours.

The Bellville Police Department was requested to make contact with Oswalt's family members in reference to the above summary (Columbus Police). Apparently, Columbus Police attempted to make contact with Oswalt's family members in an attempt to diffuse the situation.

According to the report, "All of the family currently present stated they will not go to assist. They were unwilling to participate in the slightest, due to being tired of dealing with Michael, and stating that they believed if they were to be involved in any negations all they would do is aggravate the situation further. I was advised the best to advise (sic) they could give is to shoot him if he is hurting people.
