The information was obtained from the BCI Criminal Intelligence Unit (CIU) and the Ravenna Police Department (RPD).

SA Goudy reviewed the information and noted the following:

Prior Law Enforcement Encounters

RPD received information about a male walking around the RPD station at 0323 hours. When officers encountered the male, he was recognized as Fries from prior encounters. Officers indicated that Fries was outside removing his pants and underwear and attempted to place them into the drug take back box. When asked what he was doing, Fries told officers that he had drugs on him and wanted to place them into the box. Fries put his clothes back on soon thereafter. Fries told officers that he just got released from the Portage County Justice Center and he has no money or cell phone. Officers eventually transported Fries to University Hospital for a voluntary evaluation.

RPD responded to a suspicious activity complaint involving Fries and NEO MED Police Department. Fries said he was trying to get home to Akron. Furthermore, officers contacted the Oriana house and determined that Fries was supposed to be there. Fries was eventually dropped off at the Oriana house in Akron without incident.

that he had a warrant, Fries said, "fuck that" and began to ride away on his bicycle. At that time, Fries resisted arrest and tried to escape. Fries was eventually taken into custody and transported to the Portage County Justice Center. After Fries was turned over to the correction officers, he fought with them which resulted in Fries getting tased and placed into a restraint chair.

I advised the male to back up and due to his clearly agitated state I requested additional units. The male subject began yelling at both me and Kyle. I advised Kyle to distance himself however he was still yelling at the male. Kyle eventually complied. I then attempted to speak with the male, who I identified as Matthew Fries. Matthew was extremely sweaty, talking fast and pacing back and forth. Matthew advised he was looking for his girlfriend who he stated walked off. Matthew also advised he was coming from the tent he stayed in off the Hike & Bike Trail. As Matthew was speaking with me he was flicking a lighter in his left hand repeatedly. I then detained Matthew into handcuffs.

After speaking with Kyle, he advised he didn't know if there was any damage but he insisted he needed to leave as he was going to be late. Kyle declined to provide a written statement and he was then released from the scene. Ptl. Milush, Ptl. Fife and Ptl. Erb all arrived. The lighter Matthew had was collected by Ptl. Fife and secured in my cruiser. Matthew was still agitated and was yelling for officers to quit stalling and take him to jail. I then read Matthew his Miranda Rights and at first he wouldn't answer questions. I advised Matthew of my suspicion of him possibly setting a brush fire and he said he didn't set any fires. He was then placed into the rear of P-8 and Ptl. Erb went to assist RCFD at the site of the fire.

PCSO was requested to the scene due to the fire occurring in their jurisdiction. I then asked Matthew if he would speak with me again and he began to say he set the fire. I asked Matthew how he set it and he stated he lit the tent with his light while inside and he stood in it until it got too hot for him to handle, then he got out. When I asked Matthew why he set it, he stated it was to spread awareness to the Hep C community where his tent was. I then asked Matthew to recall everything from the start and he got agitated and stated he didn't want to talk without a lawyer. He was then placed back into P-8.

A short time later Matthew began to hit his head on the partition of my cruiser. After officers told him to stop he quickly did and then began to calm down. Ptl. Erb then returned and advised a single tent burned and it appeared to be Matthew's. A short time later Dep. O'Neil #160 with PCSO arrived. Matthew was placed into his cruiser and Dep. O'Neil advised a PCSO detective would be en route to the scene. The lighter was also turned over to Dep. O'Neil. Officers stood by until Det. Springer with PCSO arrived and interviewed Matthew. PCSO then took custody of



Matthew and took over the investigation. I then cleared.

On [REDACTED] at approximately 0651 hours, Ptl. Wain advised he was out with a subject at the Elks Lodge on N. Freedom Street. Several moments into the encounter, Ptl. Wain stated the subject had become agitated and he requested additional units to his location. I activated my overhead emergency lights and siren, proceeding in an emergency fashion to Ptl. Wain's location .

Ptl. Fife #418 and I arrived at the location, to which Ptl. Wain was securing a male subject, later identified as Matthew Fries. Fries was uncooperative and hostile towards officers. During the course of the encounter, Fries was secured in Patrol Vehicle #8 (P-08) by Ptl. Wain. Fries began hitting his head within the cruiser, to which the door was opened to instruct him to stop. Fries then attempted to exit the cruiser, shouting at officers. Due to the safety hazard Fries presented, as well as prior incidents of Fries being combative, I immediately grabbed Fries by the left arm and pressed, pushing him back into the cruiser.

Prior to this incident, I had docked my body-worn camera at Ravenna Police Station in order to upload footage from the course of the night. Prior to the incident, I was re-fueling my cruiser, intending on securing another camera at the Motor Pool upon completion. The incident occurred before I was able to secure another camera and due to the concern of safety for Ptl. Wain, I immediately made my way to his location. As such, no body-worn camera footage is available for this incident.

[REDACTED] was contacted while on scene and he brought me BWC #30, which documented the rest of the incident.
