On Friday, January 21, 2022, at approximately 1330hrs, SA Dan Boerner met with BCI SAs Chuck Moran, Matt Armstrong and Andy Harasimchuk at the Canton Police Department (221 3<sup>rd</sup> St., Canton, Ohio 44702) in reference to an officer-involved critical incident investigation.








Figure 2, Ofc. Huber estimated perspective

SA Boerner was requested to photograph Officer Robert Huber in his uniform (shirt, pants, boots and outer carrier) similar to what Ofc. Huber was wearing the night of the incident. With Ofc. Huber's attorney present, SA Boerner photographed Ofc. Huber with a scale present (Figure 1, Overall photograph). The purpose of the photographs was to document the approximate height of Ofc. Huber, the approximate height of the body worn camera (BWC) and the approximate height of Ofc. Huber's eyes. Using this data, BWC footage and scan data collected the night of the incident, still images and panoramas of Ofc. Huber's perspective and of the BWC perspective were created and provide to investigators (Figures 2-3, Ofc. Huber and BWC perspectives)<sup>1</sup>.


Figure 3, BWC estimated perspective








Figure 5, James Williams' estimated perspective, 6'0
