**Narrative:**

On Tuesday, January 17, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Todd Clark (Clark) reviewed reports from the Barberton Police Department (BPD). On December 28, 2022, BPD Sergeant Ben Knorr (Knorr) provided SA Clark with an audio file of the 911 call titled, "**12-26-22 08.56.42 Emergency (911-3)**," and three PDF files titled, "**CAD call BPD**" (2 pages), "**CAD call BFD**" (1 page), and "**Barberton Fire run report**" (11 pages).

On January 5, 2023, Knorr provided an Excel spreadsheet titled, "**BPD MDT Messages- Barberton Chats for BCI**," and a PDF file (42 pages) titled, "**BPD MDT chats/messages**," to SA Chuck Moran (Moran). On January 11, 2023, Knorr provided the BPD incident report titled, "**BPD Incident Report 202204631**" (15 pages) to SA Moran.

SA Clark reviewed the files and noted the following:

**12-26-22 08.56.42 Emergency (911-3)**

The call began with a female yelling, "Get away from me!" The female told dispatch she was in the YMCA parking lot and a male was following her, asking for her keys and bookbag. The female said the man tried to take her keys and bag from her. The female said the male was white. The female said the male was wearing jeans and a black coat. The female told the dispatcher she was in the YMCA, and the male was on the sidewalk looking for her. The female said the male was yelling at other people. The male told the female he would keep following her until she gave him her stuff. The female identified herself as "Meg."

**CAD Call BPD**

The report outlined BPD's receipt and response to the 911 call.

- Officer ██████████ (██████████) told Dawson he tried to deploy his Taser and it did not work. ██████████ transitioned to his handgun and fired one round, striking Zoran in the center-mass area.
- Dawson indicated ██████████'s taser was taken to the armory and checked. Dawson indicated the Taser would not turn on and was not active.

Page 13 – Supplement Report completed by Officer Anthony Memmer (Memmer)

- YMCA employee Keith Murphy told Memmer that he received an email from a member named Jamy Bechler (Bechler). Bechler emailed YMCA staff saying he saw the incident.

It should be noted that on page 8 and page 15 of the report, supplements were completed by Officer ██████████ and Officer ██████████ SA Clark did not review the supplement reports due to the possibility of the reports containing Garrity information. The supplements were redacted by SA Moran.

DISPATCHED FOR MALE WHO WAS SHOT. OIC AND MED 1 DISPATCHED WITH THE INTENT TO STAGE. PD ALREADY ON SCENE, STATES SCENE WAS SAFE AND REQUESTED THE PARAMEDICS STEP IT UP. AT THIS TIME OIC DISPATCHED MED 3 AS ADDITIONAL MAN POWER. OIC AND MEDIC ONE ARRIVE ON SCENE, SCENE WAS SAFE AND EVERYONE WAS WEARING APPROPRIATE BULLETPROOF PROTECTING CLOTHING. BARBERTON PD WAS AROUND A MAN IN THE PARKING LOT WHICH THEY ASSESSED FOR WEAPONS. THE MAN WAS LAYING SUPINE, WITH HIS SHIRT LIFTED AND AN OBVIOUS BULLET WOUND TO THE UPPER QUADRANT. POLICE SAY THERE WAS EXIT WOUND IN THE BACK AND THIS WAS CONFIRMED BY THE PARAMEDICS. POLICE STATE THIS WAS AN OFFICER RELATED SHOOTING, ONLY ONE SHOT WAS FIRED AND IT WAS A 45 CALIBER BULLET. PT RAPID ASSESSMENT SHOWED AGONAL RESPIRATIONS , PT PUT ON COT, NO PULSE WAS FELT SO CPR BEGAN AT THAT TIME. PT LOADED INTO THE SQUAD, CPR RESUMED. IO ESTABLISHED, PADDLES PLACED ON PATIENT REVEALING PEA. ONCE IO WAS ESTABLISHED EPI WAS GIVEN. AIRWAY SECURED WITH I GEL, PATENT AIRWAY FOR VENTILATION. CLOTHING CUT AND ASSESSED FOR MORE TRAUMA WITH NONE NOTED. Reserve Officer Sunkin and myself were listening to radio traffic and it sounded like officers were trying to stop a suspicious male that they had been dispatched for. While grabbing my coat officers stated that he had a knife and shortly after we heard radio traffic that shots were fired. We were there rather quickly and I immediately moved in to help cuff Zoran. Once cuffed we began to pat him down and search for his wound. We had to cut his coat off of him and then lifted his shirt to find an entry wound to the center torso. We rolled him and found a lower back exit hole. He was not visibly bleeding and there was no external bleeding to control. We were calling for medics and began to check for a pulse as he began to go in and out of consciousness.

Medics arrived and began to work on Zoran. Shortly after arriving they began to perform CPR and we removed the handcuffs so that they could really work on life saving measures. Medics left for Barberton Hospital, but they were diverted to Akron City. Officers on scene then began notifications that we had an officer involved shooting and started looking for witnesses. Evan Kuhn, a YMCA employee, stated that he witnessed the event unfold and that the YMCA would also have video footage of most of the call.

Officers secured the scene and called for the Detective Bureau and Sgt. Donley had notified Chief Morber. Officers stayed on scene with the involved officers and at some point Sunkin brought Officer [REDACTED] to the station. Initial witness and involved officer statements all matched and sounded like Zoran had presented a knife (that was on scene laying near his body on arrival) and advanced on officers, forcing one officer to fire his weapon.

Officer [REDACTED] told me that he had tried to deploy his taser and that it did not work. He transitioned to his handgun and fired one round striking Zoran in the center mass area. Zoran dropped to the ground after being struck with the round. Officer [REDACTED] asked that his wife be notified and she was spoken with briefly. At some point it was time to send Officer [REDACTED] to the station and Officer Green stayed with him at the station.

Once BCI arrived I met with Special Agent Supervisor Jon Lieber and he accompanied me into the station. We did a round count and verified that all of Officer [REDACTED]'s rounds were present and accounted for. We then did the same with Officer Shield's handgun, which was kept by BCI for evidence. Officer [REDACTED] also mentioned that his Taser did not deploy and that was checked in the armory and would not turn on and was not active. BCI took the Taser as well for evidence. Officer Shield's weapon was short one round and the video confirmed that he fired one round. Officer [REDACTED] was issued my personal M&P 45 to replace his while it is in evidence. Special Agent Lieber and myself did watch Officer [REDACTED]'s body camera footage which confirmed that only Officer [REDACTED] fired his service weapon. The video confirmed that we secured and then tried to render aid to Zoran.

At the station I was able to view Officer [REDACTED]'s video with Agent Lieber and then later viewed Officer [REDACTED] video as well. After this event, extra personnel were called in to help with the road. The Detective Bureau, BCI, and attorney Brian Holb from the OPBA all made there way to us in a very timely manner.

While they were investigating the call I heard Ptl. [REDACTED] radio that the suspect was in the area, then running, then he told Ptl. [REDACTED] to speed it up and that the suspect had a knife. I was driving to the area to assist them with the call and was in the area of W. Park Ave./ 3rd St. NW when "Shots Fired" came across the radio.

As I arrived at the scene I pulled my cruiser E/B on W. Lake Ave. from 3rd St. NW. Ptl. [REDACTED] was standing keeping cover on the suspect who was on the ground on his back to the south of Ptl. [REDACTED] I observed a knife in the snow near Ptl. [REDACTED] Ptl. [REDACTED] was over top of the suspect and appeared to be wrestling with him. I grabbed the suspect's arm and handcuffed it, at this point Lt. Dawson arrived and the three of us were able to get the suspect cuffed and under control.

We called for the Barberton Paramedics to respond to treat the suspect. We cut off his backpack and coat/shirt looking for wounds. Paramedics arrived and began treating the suspect, the cuffs were removed after the suspect was secured and searched.

At this point I directed Res. Ptl. Sunkin and Ptl. Green to secure the scene with caution tape. I had Ptl. [REDACTED] and Ptl. [REDACTED] sit in their cruisers where it was warm until we could get the scene secured and additional personnel to assist with the incident. Ptl. Green was also directed to take some photographs of the scene and then to gather the names and phone numbers of any people who may have witnessed the incident. I called Chief Morber who made arrangements for the Detective Bureau to come to the scene, and I stayed at the scene to make sure that it was secure until Sgt/Det. Knorr and Det. Memmer arrived and I briefed them on the incident.

The suspect then came towards me with the knife in his right hand I discharged my firearm once striking the suspect in his abdomen. The suspect then fell but still refused to drop his knife. I radioed dispatch that shots were fired and send EMS.

I continued to hold my service weapon on the suspect while Ptl [REDACTED] and other officers got the knife from the suspect. The suspect continued to resist and was finally handcuffed. After the suspect was handcuffed medical treatment was administered to the suspect.

Det. Hill and I were assigned to go to Akron City Hospital. Our dispatch had been advised that Zoran had passed away in the E.R. We arrived to the Hospital at 1100 and we were taken to the Operating floor by security. We donned PPE and were escorted in to the operating room by a nurse. To our surprise, Zoran was still alive and was actively being operated on. We left the operating room and waited at the nurses station. While we were waiting, Agent Charles Snyder from BCI arrived, and advised us that he would be helping in BCI's investigation. Agent Snyder donned PPE and went in to the operating room.

We were told that Zoran's heart had stopped in the Emergency room, but his chest was opened up so that more intense life saving measures could be performed. We believe this is where the confusion happened that caused someone to call our dispatch and say that he had already passed. A Summa Police Officer advised us that Zoran came in with an Akron General ID bracelet from yesterday, and that was put with his personal effects. At 1149 I was informed by the nurse at the nurse's station that they were going to stop operating on Zoran and they believed that he would not be able to continue life. Agent Snyder came back to the nurses station a few moments later, and informed me that the Surgeon pronounced Zoran's death at 1148. Agent Snyder was given all of Zoran's personal effects that the operating room had, they were unable to find any ballistic evidence. The surgeon stated that he believed Zoran suffered a perforated small intestine x2, a perforated colon, and a "large vessel" had been perforated.

Agent Snyder advised us that he would be contacting the M.E.'s Office.

I was contacted by Chief Morber at approximately 9:16 a.m. requesting me to respond to an officer involved shooting incident. I then contacted dispatch and Sgt. Donley to obtain further information. After learning more details, I contacted the Bureau of Criminal Investigation and requested their assistance.

Det. Memmer and I arrived at the police department around the same time. We gathered equipment and responded to the scene. On our arrival, Chief Morber, Ptl. Green, Sgt. Donley, and Lt. Dawson were standing outside of the crime scene area which was protected by crime scene tape. Ptl. [REDACTED] was sitting in a patrol car, which was parked on W. Lake Ave.

We were briefed on the incident and told Zoran had died while at Akron City Hospital. I sent Det. Hill and Det. Laurella to Akron City Hospital while Det. Memmer and I remained on scene. Ptl. Green was relieved by Ptl. Dalessandro for scene security. Ptl. Green then left the scene with Ptl. [REDACTED]. I assigned Ptl. Dalessandro to keep an entry log to the scene. Sgt. Donley turned over a brown paper bag containing some of the contents of Zoran's pockets. I secured the bag in the detective bureau truck then later turned it over to BCI when they arrived.

While waiting for BCI, Det. Memmer followed up with the YMCA to check for surveillance video and I took photographs of the scene. I only photographed the scene from outside of the crime scene barrier. BCI Special Agent Charles Moran arrived on scene first followed by other investigators and members of their crime scene unit. BCI was briefed on the incident and they began their investigation and crime scene processing. Det. Memmer was able to obtain surveillance video from the YMCA and turned over a copy to BCI. Det. Memmer and I remained on scene to assist BCI and to provide scene security. At one point, the owner of the truck inside of the scene, Larry Goodman, briefly entered the scene to inquire about his truck. Larry was escorted out of the scene area and advised he could get his truck when the scene is released.

BCI located paperwork belonging to 294 Wooster Rd N in Zoran's property. Ptl. Dalessandro remained at the scene with members of BCI while Det. Memmer and I went to 294 Wooster Rd N with BCI and found the property to be condemned. The building appeared to be boarded up and secure, however, there were footprints leading to a mailbox on the property. It is unknown why the paperwork was in his property.

It was discovered Zoran had a warrant out of Cuyahoga Falls Police Department from an incident that occurred 12/25/22 involving threats towards his mother (CFPD report# 2022-00037213). It was also discovered Zoran was involuntarily admitted to the hospital by Akron Police on 12/24/22 (APD report# 22-152789). Zoran's Facebook account was found to have numerous recent disturbing posts. We do not have any in-house history involving Zoran in Sundance.

At 0917 hours I was contacted by Chief Morber and advised that there had been an officer involved shooting. He then asked me to respond and to coordinate with Sgt. Knorr so that we could assist with the investigation. He also asked me to contact Det. Hill and ask him to come in as well.

Sgt. Knorr and I arrived at the police department just seconds apart. We gathered evidence collecting equipment, a camera and items that we may need. We then responded to the scene and were briefed by the officers. The scene had already been secured and was surrounded by police caution tape. There were officers guarding the perimeter and Ptl. Dalessandro was assigned to keep an entry/exit log. Sgt. Knorr had already called B.C.I. and they were en route. B.C.I. showed up a short time later and took control of the scene.

Ptl. Green informed me that he has a detailed list of potential witnesses. I asked him to attach all of their names and information to the police report. I was also advised that there is a witness, Evan Kuhn, working inside the YMCA. I was told the YMCA may have surveillance video and there could be additional witnesses.

I went inside the YMCA and was greeted by the District Executive Director, James Sawin. James introduced me to employees Evan Kuhn and Kevin Murphy. Evan explained that he was working outside at the time of the incident. He said he saw most everything, except the shot being fired. I then told Evan that myself or someone else will reach out to him shortly, to obtain a recorded statement. Kevin then showed me that he had already downloaded and saved a copy of the surveillance video. He provided me with a copy on a memory stick. James also informed me that had received an email from a member named Jamy Bechler. Jamy emailed the staff saying he saw the incident through the windows from inside the YMCA.

Kevin then showed me a segment of the video. I could see what appeared to be Officers [REDACTED] and [REDACTED] talking with the subject and backing away from him. I could also see that a pine tree was blocking a large portion of the view. He then showed me a segment from the YMCA front parking lot. In this segment he identified the subject as the male who appeared to be following two women. He said one of the women is "Meg," the person that came in and called 9-1-1. He said the other was a woman that Meg had been asking to call 9-1-1. James used the YMCA membership data and identified the second woman as Morgan Morrisey.

After speaking with the staff members, I asked Kevin for a second copy of the surveillance video. I then walked back to the scene and gave B.C.I. all the names and information I was able to obtain. I also gave them the memory stick that Kevin had provided. I then stood by offering any assistance I could provide.

I was later flagged down by a woman from Aspire Employment Agency. She identified herself as Abigail Fairchild. She wanted to show officers that she had found Zachary Zoran's Facebook page and it contained several bizarre and threatening comments. I relayed this information to B.C.I. as well.

When B.C.I. informed us that they were almost finished and getting ready to leave, they then asked us about an address on Wooster Road North. They said they found a piece of mail with the name "Betty"

and the address "294 Wooster Road North." We then agreed to meet them there to investigate. The address turned out to be a condemned bar and apartment building. The premises was secure as it had been boarded up. Judging by a single set of footprints in the snow, it looked as if Zachary may have rummaged through a mailbox while walking by. Sgt. Knorr and I continued to walk the area with B.C.I., but found no further evidence or areas of concern.

Upon arrival, I spoke with the victim, Margaret, inside the lobby of the YMCA. Margaret was visibly shaken and crying. Margaret was able to give a brief description of the incident. While speaking with Margaret, Margaret observed the suspect in the parking lot behind Lakeview Methodist Church.

I advised Margaret to stay inside the YMCA, and that I was going to speak with the suspect, who was later identified as Zachary Zoran. While pulling out of the YMCA, I observed Zachary squatting down in front of a vehicle, that was parked in the parking lot behind Lakeview Methodist Church. I pulled up and asked Zachary to come speak with me. Zachary disobeyed my commands and started walking away. Zachary then turned toward me and a observed a knife in Zachary right hand . I immediately pulled out my service weapon and ordered Zachary to dropped the knife.

Zachary continued to walked away from officers and wouldn't dropped the knife. After several attempts to get Zachary to drop the knife, Zachary started walking aggressively toward officers. Officer # fired one round and struck Zachary in the lower abdomen. Officers render aid until Barberton Fire took over life saving efforts.
