Ms. Tipton provided a printed statement from which was a summary of involvement in the incident. was asked to read his statement aloud to refresh his memory. After reading, signed his statement, and he concurred that was an accurate representation of what he recalled from the event.	it
wrote in his statement:	
"I arrived for roll call, we were informed of a call that had taken place on second shift where officers were called to a residence at or near 246 Chittenden Avenue where there were reports a man with a knife. The individual refused help from officers, and as he was determined to be in the residence alone, officers withdrew. We were shown a picture of the individual from a previous arrest. He was a middle eastern male, bald, and in his late 20s-30s."	of
SA Gore clarified with that the location was actually 235 Chittenden Ave., not 24 Chittenden. (Note: From other officers, it was determined that the photo shown of Lamine Mahmoudi was from his driver's license, not a prior arrest.)	6
statement continued:	
"At approximately 10:30 p.m. we received a substantially similar call. I believe the call came from one of the suspect's roommates, who was at a nearby gas station, stating the suspect was in the residence at 246 Chittenden Ave. with a knife. I responded, along with CPD Although the residence was short walk from the substation, I drove cruiser so we would have cover if necessary.	а
When I arrived at the Chittenden address, to a man who they had detained, initially thinking that man may be the suspect. They continued to speak to the man near my cruiser, as I proceeded on foot to the rear of the residence on Chittenden. The house appeared to be a two-story duplex style residence with rear doors on the right and left side leading into two separate apartments. There was an external stairwell on the right (east) side of the residence, leading to a landing area. The suspect was believed to live in the right (east) part of the residence. I looked a window on the east side of the residence and saw a man matching the suspect's description inside. After looking in the window, I returned to the rear of the residence, where multiple other CPD officers were located, including CPD Officer Housler, who had a rifle. Officers around the perimeter of the residence verbally made each other aware of their location so that everyone knew to watch for potential crossfire."	e , in
wrote that after he returned to the rear of the residence, the suspect (Mahmoudi opened the door and revealed himself briefly:)
"The white sedan facing west/northwest was determined to belong to the man being detained by the man's keys and cell phone from the vehicle to him. Suddenly, the suspect opened the rear door of the residence. I could see his left hand, which was empty, but his body was bladed such that I could not see his right hand. He appeared to be shaking his head and mumbling something, but I could not understand him. I, along with other officers, yelled commands to the effect of "show us your hands!" and "walk out!". The suspect stood in the doorway for about ten seconds, and the closed the door and went back inside."

continued in his statement that a social worker with a Mobile Crisis Response (MCR) team attempted to establish a dialogue with the suspect via a loudspeaker, but the effort was unsuccessful. According to supervisors on scene made the decision to "disengage." estimated the call lasted twenty-five to thrity-five minutes.
wrote that as he was returning to the substation, he encountered an unidentified male onlooker with a tourniquet in one of his back pockets. explained that from the way the male was dressed, he thought that he was possibly an off-duty officer. determined that he was actually just a curious citizen – perhaps a neighbor – who wanted to be helpful. said he asked the man to move on.
wrote that he recalled hearing that the suspect possibly left his residence, and he described the point when the suspect approached officers at the substation:
"At some point I remember being informed that an individual matching the suspect's address had left the Chittenden house, gotten into the red sedan that we had previously noticed, left for a period of time, and then returned. At approximately 1:30 a.m., I was in my cruiser in the parking lot behind (north of) the substation. The cruisers were lined up east to west in, numerical order. continued to describe the encounter:
"I activated my body worn camera and exited my cruiser. The other officers exited their cruisers. We walked north/northeast across the parking lot and then fanned out and

The suspect was placed in handcuffs. _______ began CPR, _______ maintained pressure on a headwound, and _______ searched the suspect's lower extremities for any wounds in need of attention."

wrote that he began securing the scene by using his police vehicle to block one of the entrances to the substation. He said he later reported to the Midwatch substation, then to the CPD Training Academy.

explained that thought he fired four or five rounds, but the round count conducted at the time his weapon was collected revealed that he actually shot six times. estimated that the suspect was fifteen to twenty feet from him when he fired, and he expressed that he did not believe he had any reasonable alternative given the circumstances.

STATEMENT OF OFFICER

BADGE:

This statement is in regards to my involvement in an incident that occurred on Monday, September 10, 2024, between approximately 1:25 a.m. and 1:35 a.m. near 248 East 11th Avenue in Columbus, Ohio. I am voluntarily providing this statement as part of the investigation being conducted by the Bureau of Criminal Investigation (BCI).

My date of hire with the Columbus Division of Police was in I obtained my

OPOTA Certification in I served in the I was previously
a law enforcement officer at Ohio Health in Dublin from 2011-2012 and with the Ohio State

Highway Patrol in Franklin County from 2012-2016. I do not have any discipline for outside of policy use of force. My regular assignment is

off. On the day of the incident, I was in cruiser I was not working with a partner. I was wearing my CPD uniform, consisting of navy pants and a navy short sleeve shirt with my

CPD badge on the front and "COLUMBUS POLICE" on the back. My body worn camera

(BWC) was mounted on the chest of my shirt. I was not wearing a hat or gloves. I was clearly identifiable as a Columbus Police Officer

I was armed with a division-issued Smith and Wesson M&P 2.0 9mm which was loaded with division-issued ammunition. I was current in my range qualifications. I was not carrying any backup firearms. I was not taking any medication that would in any way affect my ability to carry out my responsibilities and duties as a police officer. I was well rested at the start of my regular shift. I had not consumed any alcohol in the 24 hours prior to the start of my shift. I do not wear glasses or contact lenses and my vision is good. I do not wear a hearing aid and my hearing is good. I do not suffer from any disabilities that would impair my ability to perform my responsibilities as a police officer.

I arrived for on September 9, 2024. During roll call, we were informed of a call that had taken place on second shift where officers were called to a residence at or near 246 Chittenden Avenue where there were reports of a man with a knife. The individual refused help from officers, and as he was determined to be in the residence alone, officers withdrew. We were shown a picture of the individual from a previous arrest. He was a middle eastern male, bald, and in his late 20s-30s.

At approximately 10:30 p.m. we received a substantially similar call. I believe the call came from one of the suspect's roommates, who was at a nearby gas station, stating the suspect was in the residence at 246 Chittenden Ave. with a knife. I responded, along with CPD Officers

Although the residence was a short walk from the substation, I drove cruiser so we would have cover if necessary.

When I arrived at the Chittenden address, were speaking to a man who they had detained, initially thinking that man may be the suspect. They continued to speak to the man near my cruiser, as I proceeded on foot to the rear of the residence on Chittenden. The house appeared to be a two-story duplex style residence, with rear doors on the right and left side leading into two separate apartments. There was an external stairwell on the right (east) side of the residence, leading to a landing area. The suspect was believed to live in the right (east) part of the residence. I looked in a window on the east side of the residence and saw a man matching the suspect's description inside. After looking in the window, I returned to the rear of the residence, where multiple other CPD officers were located, including CPD Officer Housler, who had a rifle. Officers around the perimeter of the residence verbally made each other aware of their location so that everyone knew to watch for potential crossfire.

There were three civilian cars at the rear of the residence- a red sedan and two white sedans. One of the white sedans was facing north, toward the rear of the residence. The other white sedan was on the left side of the residence, facing west/northwest. The red sedan was on the right side of the residence facing east/northeast. Officers radioed back and forth to determine if anyone had visual confirmation the suspect was in the residence and if he was alone. I heard someone say they could see the suspect inside with a large knife, but did not see anyone else. I heard one officer say that the residences on the right and left side shared a basement, but the basement was locked such that the suspect could not get to the residence on the other side. I was concerned the suspect could get through that door and into the other side of the house.

The white sedan facing west/northwest was determined to belong to the man being detained by

They asked me to shut off the vehicle and bring the man's keys and cell phone from the vehicle to him. I then returned to the rear of the residence, standing behind rear driver's side door of the white sedan that was facing north. CPD

was standing near me, slightly to my right (south). Suddenly, the suspect opened the rear door of the residence. I could see his left hand, which was empty, but his body was bladed such that I could not see his right hand. He appeared to be shaking his head and mumbling something, but I could not understand him. I, along with other officers, yelled commands to the effect of "show us your hands!" and "walk out!". The suspect stood in the doorway for about ten seconds, and the closed the door and went back inside.

I knocked on the rear door of the left (west) side of the residence to ensure that no one was home. No one answered the door. At some point I heard it aired over the radio that the suspect's first name was Lamine. CPD Lt. Engles and Sgt. Van Dusen arrived at the rear of the residence, as did the Mobile Crisis Response unit. We began arranging ourselves to knock on the

door to make contact so the Mobile Crisis Response unit could make announcements for the suspect to come outside without any weapons and speak to us. It was decided shortly thereafter by supervision that we would not knock; the Mobile Crisis Response Unit would just make announcements.

A social worker with the Mobile Crisis Response Unit began making announcements over the loudspeaker for Lamine to come to the back door with nothing in his hands so that they could get him whatever help he needed. Announcements continued for approximately 5-7 minutes. The suspect did not come to the back door or make any attempts to communicate with officers. Given that the suspect would not communicate with us and it was determined that he was alone in the residence, supervision made the determination for officers to disengage. I estimate that I was at the residence for a total of 25-35 minutes.

As I returned to the substation, I noticed a man in the substation parking lot with what appeared to be a tourniquet in his back pocket. After briefly asking him why he was there, I asked him to leave the parking lot. I then returned to my normal duties.

At some point I remember being informed that an individual matching the suspect's address had left the Chittenden house, gotten into the red sedan that we had previously noticed, left for a period of time, and then returned. At approximately 1:30 a.m., I was in my cruiser in the parking lot behind (north of) the substation. The cruisers were lined up east to west in numerical order.

Was in I was in and was in We all had our windows down and were talking amongst ourselves. A CPD prisoner transport vehicle (PTV) was parked on the other side of the parking lot; to my northwest. I saw a man generally matching the

suspect's description walking eastbound down the alley behind the substation. I asked words to the effect of "is this our guy?".

I activated my body worn camera and exited my cruiser. The other officers exited their cruisers. We walked north/northeast across the parking lot and then fanned out and created a diagonal/semi-circle; was to my left; was to my right. I temporarily lost sight of the suspect as my view was obstructed by the PTV. Once the suspect passed the PTV and continued to walk eastbound I could see that he had a large knife in each of his hands. I gave multiple commands to the effect of "Put it down. We don't want to hurt you". I heard other officers giving commands for the suspect to drop the knives. The suspect continued to walk east, toward officers. I moved backwards (southeast) in order to maintain distance between myself and the suspect.

After about thirty seconds of giving commands for the suspect to put down the knives, the suspect stopped walking and turned his body such that his left side was forward. CPR, maintained pressure on a headwound, and searched the suspect's lower extremities for any wounds in need of attention.

I began securing the scene. I used my cruiser to block the southeast entrance to the substation. I returned on foot to see if any assistance was needed in rendering aid to the suspect. I asked if she wanted me to take over chest compressions. She declined. I asked if he needed a tourniquet for any leg wounds; he did not. Other CPD officers arrived on scene and began assisting. Lt. Ingles then pulled myself and the other involved officers from the immediate scene.

I left the scene and was taken to the 4 precinct midwatch substation and then the CPD Training Academy. CPD Officer Jacob Velas acted as my officer support. This ended my involvement with the incident.

I fired six shots at the suspect. My shots were fired from a standing position. I used my sights when I fired. My shots were fired in a northwest direction. I believe I was approximately 15-25 feet from the suspect at the time I fired. There was approximately two to three seconds between my first and last shots. My target was the suspect's center mass. The backdrop for my shot was the empty alleyway behind 248 E. 11th Street. I did not have any cover or concealment. I had light from the streetlights and the light on my weapon. I stopped firing because the suspect was on the ground and no longer presenting a threat.

At the time I fired my weapon at the suspect, I do not believe I had any reasonable alternative to protect my life and the lives of the other officers on the scene. I did have a taser with me, however, given that I believed the suspect was going to throw a meat cleaver style knife

to stab me and/or other officers, I did not believe it would be appropriate to counter their deadly force with a taser.

I know the name of the suspect that I fired at was Lamine Mahmoudi. To my knowledge I have not had any other personal or professional dealings with Mr. Mahmoudi.

I have now had an opportunity to review video footage from this incident. After seeing the footage, I now recall asking if the suspect had a knife as we exited our cruisers. After seeing the footage I now know the suspect said words to the effect of "I'm not dropping nothing" immediately prior to squaring his body to officers and advancing south, directly toward officers, with the knives in his hands.

This concludes my statement.
