**Narrative:**

On June 6, 2025, BCI Special Agents Stacey Fifer (SA Fifer) and John Tingley (SA Tingley) interviewed civilian Pamela Spiker (Spiker) at 10240 Busenburg Road regarding the officer involved critical incident. Spiker resides next door to where the incident occurred. Spiker told agents she has lived next door to the same residents for the past 20 years.

When asked if she was aware of any problems at her neighbor's residence, Spiker said, "Yea... he and his son fight alot...I mean really fight." Spiker indicated "Jared" lives with his daughter next door.

Spiker initially said she did not hear anything the morning of the incident, but when asked further, she confirmed she heard gunshots. When asked around what time she heard the gunshots, Spiker said it was around 3:30 - 4:00 am. Spiker said she had not been to sleep yet. SA Fifer asked Spiker how many gunshots she heard, and she said, "About four."

Spiker told agents her husband "John" left the house to go find out what was going on and got arrested. Spiker said "Lloyd" was a friend of theirs and that was the reason John went to see what was going on next door. Spiker identified her husband as John Campian and confirmed he was in custody at the Knox County Sheriff's Office. Spiker did not know if John took any pictures or videos with his phone but confirmed he did have his cell phone with him when he left the house. When asked, Spiker said she did not take any photographs or pictures.

The interview was audio recorded. The recording is stored on Axon Justice as reference item E (see the recording for further details).
