Narrative:

On Tuesday, December 17, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) contacted Sally Cowan (Cowan), the registered owner of the white 2021 Jeep Grand Cherokee, that was previously reported stolen out of Sharpsville, Pennsylvania. The Jeep was involved in an officer involved critical incident which occurred in Liberty Township, Ohio. The Jeep, reported stolen by Cowan, was driven by Jason A. Cain (Cain) during the incident.

The 2021 Jeep Cherokee was secured at the Liberty Township Police Department for further processing. Upon speaking with Cowan over the telephone, she advised that she was formerly in a relationship with Cain from August of 2023 to September of 2024. Cowan further stated that sometime between the hours of 2000 hours on Thursday, December 12, 2024, and 0730 hours on Friday, December 13, 2024, Cain entered her house without Cowan's consent and took her keys to the Jeep Cherokee. Cowan further stated that she did not authorize Cain to enter her residence and/or to take her vehicle. Cowan immediately reported the vehicle stolen to the Sharpsville Borough Police Department. (Sharpsville Police Report #20241213M2224)

After explaining to Cowan the status of her vehicle, she provided verbal consent to search and process her vehicle. Additionally, a consent form was sent via email to Officer Brendan Gill (Gill) of the Sharpsville Borough Police Department to obtain a signature from Cowan while in his presence. After Cowan signed the consent to search form, Officer Gill emailed the consent form back to SA Goudy. An additional consent form was also provided and signed by Cowan to include event data recorder information.

On 12/13/2024 at approximately 07:48hrs, this R/O was dispatched to 625 W Ridge Ave. for a report of a motor vehicle theft. The complainant stated that she believed her ex-boyfriend had stolen her 2021 Jeep Grand Cherokee sometime between 20:00hrs on 12/12/2024 and the time of her report.

I arrived on scene and spoke with the complainant, identified as Sally Cowan. Sally stated that she had parked her Jeep behind her residence on 12/12/2024 and that the last time she saw it was approximately 20:00hrs. She advised that this morning at around 07:40hrs, she went outside to start up her Jeep and found it missing. She explained that the keys for the Jeep had been in her coat pocket and that said coat had been kept on a chair in her kitchen. Sally found her coat just outside of the residence on the ground with the keys missing.

Sally advised that she believed her ex-boyfriend, identified as Jason Cain, had come into the residence during the night or early morning and taken said keys. Sally stated that her basement door had been unlocked and that access could be gained to the main floor of the house via the basement. She explained that Jason was aware of this and that her dogs were friendly with him so they would not have barked.

Sally told this R/O that she and Jason had broken up some months ago but that he had been slowly taking his personal items from the residence and garage. She advised that on Sunday, 12/08/2024, she had allowed Jason to use her Jeep to transport some of his things from her residence to his new residence. She also advised that Jason had been at the residence on 12/09/2024 to collect more of his things.

Sally said that she had not given Jason permission to take the Jeep today and that she did not know where he would've went. She was adamant that she wished to pursue charges against Jason for the unauthorized use.

This R/O requested County Dispatch BOLO the vehicle information as well as Jason's descriptive information to Mercer and Trumbull County agencies as Jason was also a person of interest in the missing person's report regarding his current girlfriend, Hannah Tillery.

On 12/13/2024 at approximately 12:15hrs, Sally Cowan contacted MC911 and advised that she had found a wallet belonging to Hanna Tillery in her backyard.

This R/O traveled to 625 W Ridge Ave. and collected said wallet at approximately 13:30hrs. Sally stated that she had told Tillery, who had been at the W Ridge Ave. address on 12/08/2024, that she was not welcome on her property. Sally advised that she would like to pursue trespass charges against Tillery should evidence further suggest she was on the property. Cleared.

At above date and time, this R/O was notified by MC911 that Liberty Twp in Trumbull County was with the stolen vehicle. Liberty wished to confirmed the vehicle to be stolen. I was briefly advised that Liberty Twp had a Officer related shooting involving the occupants of the vehicle. I returned to the PD, verified that the vehicle was last reported as stolen/unauthorized use and notified MC911. MC911 advised Trumbull County 911 requested a copy of the report be faxed to them. I contact Chief Joseph, advising him of the situation before the report was disseminated. A copy of the report was faxed, report was stamped "FAXED" and placed on Chief Joseph's desk.

At approx. 21:05hrs, vehicle owner Sally Cowan called into MC911 in regards to her vehicle being found near Harbor Freight. Cowan was contacted and advised her vehicle was located but the matter was under investigation. It was advised her contact information would be given to Chief Frank Joseph for any further developments and/ information relating to her vehicle.
