

REDACTIONS APPLIED

- All officers work shifts- R.C. 149.43(A)(1)(uu), Records of the past, current, and future work schedule of a designated public service worker. As used in division (A)(1)(tt) of this section, 'work schedule' does not include the docket of cases of a court, judge, or magistrate.
- Driver's license number- R.C. 149.45(A)(1)(C)18 U.S.C. § 2741, Driver's license numbers are considered personal information, exempt from disclosure, pursuant to R.C. 149.45(A)(1)(c), and are further protected from disclosure by the Driver's Privacy Protection Act of 1994. 18 U.S.C. § 2741.
- Autopsy photos & reports- Autopsy photographs, and reports redacted, pursuant to R.C. 313.10(D) Information obtained from medical records redacted - R.C. 149.43(A)(1)(a).
- Infrastructure records- R.C. 149.433 (A)(2)- Any record that discloses the configuration of a public office's "critical systems" such as its communications, computer, electrical, mechanical, ventilation, water, plumbing, or security systems.
- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing the identity of an uncharged suspect, R.C. 149.43(A)(2)(a)
 - Officer name- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a)
 - Unit/Car number- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a)
 - Badge number- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a)
 - Any complaint numbers-including officer's name on report- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a)
 - Any IAB numbers-Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a)
 - Dates of employment with PD- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a)

- Telephone number of witnesses- Telephone numbers of victims or witnesses to a crime that are listed on a law enforcement record or report, pursuant to R.C. 149.43(A)(1)(mm)
 - LE firearm Serial Number- Law enforcement firearm serial number, pursuant to R.C. 149.433
 - SSN-149.43(A)(1)(dd) 149.45(A)(1)(a)- *State ex rel. Office of Montgomery County Pub. Defender v. Siroki*, 108 Ohio St.3d 207, 842 N.E.2d 508, 2006-Ohio-662, ¶ 18; R.C. 149.43(A)(1)(dd); and R.C. 149.45(A)(1)(a).
 - CCH- Information from the Computerized Criminal History (CCH) National Crime Information Center (NCIC) systems, pursuant to R.C. 109.57 and O.A.C. 4501:2-10-06(C)
 - Medical Records - 149.43(A)(1)(a). Information obtained from medical records redacted. R.C. 149.43(A)(1)(a).
 - Toxicology reports- Information obtained from medical records redacted - R.C. 149.43(A)(1)(a).
 - Address- Residential and familial information of designated public service workers pursuant to R.C. 149.43(A)(1)(p) and R.C. 149.43(A)(7)-(8)
 - Police Officer photos- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a) and O.R.C. 149.43 (A)(7)(g)
 - EMS Run Sheet- When a run sheet created and maintained by a county emergency medical services (EMS) organization documents treatment of a living patient, the EMS organization may redact information that pertains to the patient's medical history, diagnosis, prognosis, or medical condition R.C. 149.43(A)(1)(a), and physician-patient privilege R.C.149.43(A)(1)(v), R.C. 2317.02(B), *State ex rel. Nix v. Cleveland*, 83 Ohio St.3d 379 (1998).
 - Employee ID - R.C. 1306.23 creates an exemption for "[r]ecords that would disclose or may lead to the disclosure of records or information that would jeopardize the state's continued use or security of any computer or telecommunications devices or services associated with electronic signatures, electronic records, or electronic transactions are not public records for purposes of" the Public Records Act. Employee ID numbers are not public record, pursuant to R.C. 149.433 (2) and (3).
 - Victim's Rights aka Marsy's Law (name, address, phone number, and family member names), and 149.43(A)(1)(ii)(i) Due to their highly sensitive nature, photos of the victim at the scene of the death have been withheld. O.R.C. 149.43 (A)(1)(rr) records, documents, and information the release of which is prohibited under sections R.C. 2930.04 and R.C. 2930.07. Crime victims are provided certain rights detailed in the Ohio Constitution Article I, Section 10(a) and the Ohio Revised Code, often called "Marsy's Law" or the Ohio Crime Victims' Bill of Rights.

- Account numbers- R.C. 149.43(A)(1)(dd) & 149.45(A)(1)(d), Financial Account Numbers (including bank and credit card account numbers) Pursuant to R.C. 149.43(A)(1)(dd) and R.C. 149.45(A)(1)(d)
- Medical Conditions and Issues – General References-Not a “record” of the office. R.C. 149.43(A)(1); *see also State ex rel. Fant v. Enright*, 66 Ohio St.3d 186, 188 (1993)
- Non-record information- Information that does not document the activities of the office. R.C. 149.011(G) and R.C. 149.43(A)(1)
- FBI number- FBI numbers, pursuant 42 U.S.C. § 3789(g)
- BCI number- BCI numbers, pursuant to R.C. 109.57 and O.A.C. 4501:2-10-06
- Photos of victim - Ohio R.C.149.43 (A)(1)(ii) Any depiction by photograph, film, videotape, or printed or digital image under either of the following circumstances: (i) The depiction is that of a victim of an offense the release of which would be, to a reasonable person of ordinary sensibilities, an offensive and objectionable intrusion into the victim's expectation of bodily privacy and integrity. Photos of the victim at the scene of the death redacted. Rationale: Due to their highly sensitive nature, photos of the victim at the scene of the death have been withheld. Although there is no legal basis for withholding these photos, we have done so out of respect to the victim and his family. If you wish to view these photos, arrangements can be made.
- Restricted Portion of BWC – injury to officer. Redacted pursuant to R.C. 149.43(A)(1)(jj) and 149.43(A)(17).
- Military dates- Confidential Law Enforcement Investigatory Records (CLEIRS), pursuant to R.C. 149.43(A)(2)(a)-(d) Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: The identity of an uncharged suspect, R.C. 149.43(A)(2)(a)
- Grand jury records withheld – Ohio Criminal Rule 6(E).
- Law enforcement incident number. Records pertain to a law enforcement matter and disclosure would create a high probability of revealing: the identity of uncharged suspect, R.C. 149.43(A)(1)(h) and (A)(2)(a).
- LEADS-Information from the Law Enforcement Agencies Database Systems (LEADS), pursuant to O.A.C. 45-1:2-10-06(c)
