**Narrative:**

On Tuesday, June 21, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agents Tyler Price (Price), Tiffany Vollmer (Vollmer) and Chris Hamberg (Hamberg) conducted a neighborhood canvass in the area of Taft Ave., E. 2nd St. and S. Sugar St., in Lima, Ohio. The purpose for the canvass was to identify and interview potential witnesses to the officer-involved shooting that occurred in the alley between S. Sugar St. and Taft Ave., in Lima, Ohio, on Tuesday, June 21, 2022. During the neighborhood canvass, Special Agents Hamberg, Price and Vollmer made or attempted contact with the residents at the following addresses:

**1202 E. Second St., Lima, Ohio**

Kathleen Amerson (Amerson) stated she was asleep during the night and didn't hear or see anything. Amerson has a Ring doorbell camera; she checked to see if the camera might have caught the pursuit but the camera didn't. The camera covers the front part of the home and not the intersection of the streets.

**1201 E. Second St., Lima, Ohio**

Marcia Pitts (Pitts) stated she was sleeping when the incident occurred; when she woke up, she observed several police cars with their emergency lights on. Pitts stated they have a camera, but it faces E. Second St. and not on S. Sugar Street.

**1124 E. Second St., Lima, Ohio**

Dewitt Mayes was asleep when the incident occurred and didn't hear or see anything. The house had no cameras.

**1102 E. Second St., Lima, Ohio**

Zachary Parkinson (Parkinson) and Samantha Duval (Duval) were sleeping when the incident took place. Parkinson stated he woke up at approximately 0237 hours to hearing something like fireworks going off or gunshots going off. When asked how many shots he heard, Parkinson stated approximately five to seven shots. Parkinson added, a few minutes later, he heard sirens. Duval stated that she heard around five to seven shots going off too and observed a flash of light coming from across the street in the yard. Duval stated that's why she thought it was fireworks,

because she could see a light or some sort of light coming from the sound. Duvall stated, right after that, she heard tires squealing in the area and several police officers arriving in the area. The house had no cameras.

**1104 E. Second St., Lima, Ohio**

Jennifer Secession stated, at approximately 0245 hours, she heard around four to five shots going off; then right after that, she overheard tires squealing and then right after that, police cars had arrived in the area. The house had no cameras.

**1108 E. Second St., Lima, Ohio**

Kevin Mclurin (Mclurin) stated he was sleeping when the incident happened and woke up to a loud bang and then went back to sleep. Mclurin stated when he woke up later on, he saw all the police cars in the area. The home has no cameras.

**1121 Taft Ave., Lima, Ohio**

Daniel Evans (Evans) stated he was sleeping when the incident occurred and woke to someone yelling at someone, and he heard approximately eight shots going off right after that. Evans stated the shots were all in succession. Evans stated, when he looked out the window, he observed the deputy looking around the area and he [Evans] thought he observed another white male in the area also. Evans stated, a few minutes later, police cars started arriving in the area.
