Narrative:

On September 13, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Allison Fletcher (Fletcher) met with Captain Jeremy Young (Young) of the Cleveland Heights Police Department (CHPD). SA Fletcher provided Captain Young with CHPD [REDACTED] body worn camera (Matrix Evidence Item #034) which was previously collected as evidence on August 29, 2024, to preserve the device until a video recall could be completed.

Captain Young utilized Motorola Solutions, Watchguard Body Worn Camera Systems, software to attempt to locate footage "recorded after the fact" on [REDACTED] body worn camera. Video had been previously provided by the CHPD from [REDACTED] body worn camera, however, there was no recording located of the shooting incident. Motorola Solutions provides an option called "record after the fact" (RATF) where the camera continues to record even when it is turned off. This feature must be turned on by the agency in order for the RATF footage to be available. It was discovered this feature was not turned on and there was no footage of the shooting incident. This information was confirmed with customer service representative of Motorola Solutions, Lee Haller.

After the attempt was made, the body worn camera was returned to Captain Young. An evidence receipt was signed, and a copy has been attached to this report.
