**SUMMARY:**

On Wednesday, September 28, 2022, BCI Special Agent(s) Dan Boerner, Aja Chung, Larry Hootman, Sarah Taylor and BCI Crime Scene Technician (CST) Amy Gill assisted Lieutenant Adam Fisher and the Tuscarawas County Sheriff's Office with the processing of an outdoor crime scene located at 5611 East Third St. NE, Mineral City, Ohio in regard to an officer-involved critical incident. The scene was photographed as it was found and evidence was collected. The scene was further documented using a FARO Focus S150 laser scanner.

**DETAILS:**

On Wednesday, September 28, 2022, at 1020hrs, SA Boerner was contacted by SAS Ed Lulla and was requested to assist Lieutenant Adam Fisher and the Tuscarawas County Sheriff's Office (TCSO) with the processing of an outdoor crime scene located at 5611 East Third St. NE, Mineral City, Ohio in regard to an officer-involved critical incident. SA Boerner further learned that BCI Special Agents from the Special Investigations Unit had been requested to investigate the incident.

On Wednesday, September 28, 2022, at 1217hrs, SA Boerner arrived on scene and met with investigators. SA Boerner learned that deputies of the TCSO were dispatched to the residence for a report of an unwanted guest/Temporary Protection Order (TPO) type complaint. SA Boerner learned that the subject (ID to be Everett Michael Martin, W/M, DOB: 03/21/1979) was at the residence in violation of a TPO. SA Boerner learned that when deputies arrived on scene Martin allegedly brandished a knife. SA Boerner learned that a less-lethal device (bean bag round) was used and Martin subsequently brandished a firearm and reportedly shot at deputies. SA Boerner learned that two deputies shot at Martin, subsequently killing him.

SA Boerner proceeded to photograph the scene as it was found (Figures 1-7, Overall photographs). The scene can be described as the side entrance, the porch area, and the front yard, the side yard and the back yard of 5611 East Third St. NE, Mineral City, Ohio (Figure 8, Overhead diagram).

The scene was further documented by SA Hootman using a FARO Focus S150 laser scanner. Using the scan data, panoramas were created and provided to investigators.

While processing the scene, investigators obtained a search warrant for a vehicle reportedly belonging to the subject (a blue 2009 Ford, F-150 pick-up truck, VIN: 1FTRW14879FA00874). The vehicle was photographed as it was found and examined for items of suspected evidence. A cell phone was located in a green duffle bag on the center console of the vehicle (Figure 24, Item 1 – Blu Trac phone). Item 1 was photographed as it was found and collected as suspected evidence<sup>2</sup>.




Figure 28, Item 20

On Wednesday, September 28, 2022, at approximately 1610hrs, SA Boerner received three items of evidence from SA Arvin Clar. SA Boerner received one Smith & Wesson M+P 9mm (SN: [REDACTED]), three 9mm magazines, and one Colt AR-16 A1 rifle (SN: [REDACTED]). An Inventory/Receipt Attachment form was completed and uploaded into Matrix.

All items of evidence were retained and are to be held as evidence. The items of evidence were transported to the Ohio BCI Richfield Office and placed into temporary evidence locker #40. An Inventory / Receipt Attachment form was filled out by SA Boerner, a copy of the form was provided to Lt. Fisher for their records.

The photographs are to be uploaded into Matrix. A copy of the photographs was made and will be provided to the agency. A copy of the FARO Focus S150 scanner data (SCENE 2go) is to be placed on in the "BCI Scanner" folder on the shared directory. A copy of the search warrant is to be placed in the case file.
