Narrative:

On January 3, 2023, at approximately 1340 hours, at Ohio Bureau of Criminal Investigation (BCI) Richfield, located at 4055 Highlander Parkway, Richfield, Ohio 44286, Special Agent (SA) Nick Valente (Valente) and SA Matt Armstrong (Armstrong) photographed and examined Zachary Zoran's (Zoran's) clothing and personal property contained in the clothing which had been held in the drying room.

The personal property located in the clothing included the following: a Covid-19 vaccine card, miscellaneous business cards, paperwork from the Ohio Bureau of Motor Vehicles, bank balance receipts, pawn shop sales receipt, Best Buy store receipt, automobile insurance card, hospital bracelet, keys, ink pen, lighter, watch, headphones, overhead fan pull cords, handwritten phone number on scrap paper, Maverick cigarette box, phone charger, lease agreement, pillow case, vaping device, and \$1.52 in coins.

Zoran's clothing included the following: one pair of black Timberland boots, red and grey Ecco winter coat, two grey socks, a single black glove, jean shorts with a black belt, black boxer/brief underwear, white t-shirt, black t-shirt, and a white sweater with a black stripe.

Agents noted that bloodlike stains and a defect were visible on the black nylon underwear. Bloodlike staining and defects were also present on the white sweater, and lower abdomen area of the t-shirts.

SA Armstrong took 58 photographs of Zoran's property and clothing. Clothing items with visible defects were also photographed with a scale near the defects. The following five photographs were captured during the examination of Zoran's clothing and are included to show the location of the defects in the garments.




Figure 4, showing a black t-shirt worn by Zoran, with red and brown staining and a single defect in the lower center back area of the garment.
