On 01/02/2026, Special Agent David M. Hammond (S/A Hammond) was contacted by Mrs. Ann Spoon of the Hancock County Coroner's Office. She advised that the autopsy report for Robert Norton (03/08/1935) had been completed. S/A Hammond provided her with an email request for the report, and she provided it via fax.
