

between the State of Ohio, acting by the Department of Public Works, for and on behalf of the Ohio State Archaeological and Historical Society, and The Wege Marble & Tile Company, Columbus, Ohio, which contract calls for the construction and completion of the marble and terrazzo work on the Additions to the Museum and Library Building.

The consideration named in the contract is the sum of ten thousand, two hundred and eight (\$10,208.00) dollars. An examination of the estimate of cost reveals that the estimated cost of the marble and terrazzo is the sum of six thousand, five hundred fifty-six (\$6,556.00) dollars. It is apparent, therefore, that the amount of the contract awarded is in excess of the estimated cost.

Under date of March 5, 1928, this department rendered an opinion addressed to you, being Opinion No. 1812, in which, under similar circumstances and involving the same contractor, a contract for the marble, tile and terrazzo for the new chemistry building at the Ohio State University was disapproved. In accordance with the holding of that opinion I am compelled to disapprove the contract now under consideration.

I am returning the contract and other papers submitted without my approval noted thereon.
