Narrative:

On October 19, 2024, at 0945 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente met with SA Cory Momchilov and took possession of the three rifles fired by Mansfield Police Officers during the officer-involved shooting. SA Valente signed an evidence transfer receipt noting he took possession of these items.
