Narrative:

On the morning of September 10, 2024 at approximately 0130 hours, Lamine Mahmoudi (Mahmoudi), of 235 Chittenden Ave., Columbus, was fatally wounded during an encounter with officers from the Columbus Division of Police (CPD). The incident took place in the rear parking lot of the CPD Precinct 4 substation. Mahmoudi was armed with a meat cleaver and butcher knife when he confronted police. The Ohio Bureau of Criminal Investigation (BCI) was requested by CPD to handle the Officer-Involved Critical Incident investigation.

Prior to the critical incident, police responded to Mahmoudi's home twice on the evening of September 9, 2024 for armed, mental complaints/disturbances involving Mahmoudi. From police dispatch records, BCI Special Agent (SA) James Gore (SA Gore) identified the caller on the first complaint (CPD dispatch log **# 10000000**) as a friend of Mahmoudi's named Messaoud Mezrar. On the second complaint (CPD dispatch log **# 10000000**), the caller was identified as Sam Hasan. Sam Hasan was further identified as the owner of Mahmoudi's duplex residential building (233 and 235 Chittenden Ave.), and also the owner of two nearby Marathon gas stations. The dispatch log indicated that Mr. Hasan was not on scene, and that he was calling on behalf of one of his gas station employees, "Nair" (also later spelled "Nyier" on the same dispatch record). From responding officers' body–worn camera footage, it was deduced that "Nair" was also possibly one of Mahmoudi's neighbors at 233 Chittenden, though he was not positively identified.

Over the course of several weeks, SA Gore attempted contact "Nair" at both 233 Chittenden and the two Marathon gas stations, but he was unsuccessful. A first-hand account from "Nair" was sought to validate or refute the claim that Mahmoudi had threatened roommates, as it was alleged in the dispatch notes.

On the evening of November 8, 2024 at approximately 1800 hours, SA Gore again attempted contact with "Nair" at the Marathon station located at 1584 Summit St., as he was supposed to be working there at that time. Again, "Nair" was not present, so another employee put SA Gore in contact with Sam Hasan's son, Beelal Hasan (Beelal), by phone.

Beelal explained that he was present with "Nair" during the second dispatch run. He said that he and "Nair" attempted to speak with Mahmoudi at the front door of his residence, but Mahmoudi refused to talk and shut the door on them. Beelal added, his family had other tenants which shared the dwelling with Mahmoudi, but it was unknown at the time if any of them were present. (*Note: Police "disengaged" from Mahmoudi on both calls once they determined that he was alone in the residence, in accordance with CPD policies.*)

Beelal stated that "Nair's" last name was Badawy. "Nair's" identity was later confirmed to be via a query on the Ohio Law Enforcement Gateway (OHLEG). According to Beelal, Sam Hasan was unavailable for comment, because he was out of the country for an extended period on a family emergency. SA Gore was unable to record the conversation with Beelal Hasan under the circumstances.

With this information, the allegation that Lamine Mahmoudi threatened roommates or anyone other than himself could not be substantiated.


